**RESOLUTION REAPPOINTING MAURILIO LEON AS A MEMBER OF THE CHILDREN'S

**WHEREAS**, Article XIII of the Oakland City Charter, creates the Children's Fund and Planning Oversight Committee, whose members are to be appointed, two by each Member of the City Council, and three members by the Mayor; and

**WHEREAS**, Ordinance No. 76141 specifies the terms of members of the Children's Fund and Planning Oversight Committee and provides that each member shall serve one year terms with no limit to number of terms, and appointments to fill a term of office are only to be for the remainder of that term; now, therefore, be it

**RESOLVED**: that the Council hereby confirms Councilmember Ignacio De La Fuente's reappointment of Maurilio Leon to the Children's Fund and Planning Oversight Committee for one year term that begins August 1<sup>st</sup>, 2009 and it ends July 31<sup>st</sup>, 2010.
