

RESOLUTION No. 85 44 6 C.M.S.

RESOLUTION CONFIRMING THE MAYOR'S APPOINTMENT OF JESSICA "JESSIE" WARNER, TYFAHRA D. SINGLETON AND REAPPOINTMENT OF NOAH FRIGAULT TO THE HOUSING, RESIDENTIAL RENT AND RELOCATION BOARD

WHEREAS, Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of four members of the City Council; and

WHEREAS, Ordinance No. 11954 C.M.S., adopted December 17, 1996, and amended by Ordinance No. 12030 C.M.S., adopted December 16, 1997, and further amended by Ordinance 12273 C.M.S., adopted July 25, 2000, and Ordinance No. 12399 C.M.S., adopted January 23, 2003, creates the Housing, Residential Rent and Relocation Board ("Board") to assume all duties and functions heretofore exercised by the Housing Advisory and Appeals Board, Relocation Appeals Board, and the Housing Advisory and Appeals Board; and

WHEREAS, the Board consists of seven (7) members, two tenants, two landlords, and three neutral members, serving not more than two consecutive three-year staggered terms and one alternate for each of the three classes of members; and

WHEREAS, the Honorable Mayor Libby Schaaf has appointed Jessica "Jessie" Warner to serve the remainder of a three year term as a Neutral Representative subject to confirmation by the City Council; and

WHEREAS, the Honorable Mayor Libby Schaaf has appointed Tyfahra D. Singleton to serve the remainder of a three year term as a Tenant Representative subject to confirmation by the City Council; and

WHEREAS, the Honorable Mayor Libby Schaaf has reappointed Noah Frigault to serve a second three year term as a Tenant Representative subject to confirmation by the City Council; now therefore be it

RESOLVED, that pursuant to City Charter section 601, the City Council hereby confirms:

- The Mayor's appointment of **Jessica "Jessie" Warner** to the Housing, Residential Rent and Relocation Board to serve the remainder of the term that began February 12, 2014 and ending February 11, 2017 as a Neutral Representative, filling the seat previously held by Michael Bowie.
- The Mayor's appointment of **Tyfahra D. Singleton** to the Housing, Residential Rent and Relocation Board to serve the remainder of the term that began February 12, 2013 and ending February 11, 2016 as a Tenant Representative, filling the seat previously held by Craig Castellonet.
- The Mayor's reappointment of **Noah Frigault** to the Housing, Residential Rent and Relocation Board to serve a second term beginning February 12, 2014 and ending February 11, 2017 as a Tenant Representative, filling the seat he previously held.


