RESOLUTION AUTHORIZING THE CITY MANAGER, ON BEHALF OF THE CITY OF OAKLAND, TO APPLY FOR, ACCEPT AND APPROPRIATE THE YEAR 'ROUND FOOD SERVICE GRANT FOR PROGRAM YEAR 2000-2001 FROM THE CALIFORNIA DEPARTMENT OF EDUCATION CHILD NUTRITION AND FOOD DISTRIBUTION DIVISION (CNFDD) IN AN ESTIMATED AMOUNT OF \$743,057 AND TO EXECUTE A PROFESSIONAL SERVICES AGREEMENT IN AN ESTIMATED AMOUNT OF \$552,750 BETWEEN THE CITY AND THE OAKLAND UNIFIED SCHOOL DISTRICT TO PROVIDE FOOD SERVICES TO THE YEAR 'ROUND FOOD SERVICE PROGRAM FOR CHILDREN FOR PROGRAM YEAR 2000-2001

WHEREAS, the City of Oakland desires to apply for, accept and appropriate a Year 'Round Food Service Program Grant in an estimated amount of \$743,047 from the California Department of Education Child Nutrition and Food Distribution Division (CNFDD) and to execute a Professional Services Agreement in an estimated amount of \$552,750 between the City and the Oakland Unified School District to provide food services to the Year 'Round Food Service Program for Children for Program Year 2000-2001; and

WHEREAS, the grantor does not reimburse central service overhead charges and the Adopted Budget for FY 1999-2001 includes an offset of central service overhead charges; and

WHEREAS, the Oakland Unified School District is certified by the California Department of Education Child Nutrition and Distribution Division to provide meals and will provide services under a contract agreement during the period of January 2,2001 through September 30,2001; and

WHEREAS, the City Council finds that the performance of this service is in the public interest because of economy; and

WHEREAS, the City Council finds that this contract shall not result in the loss of salary or employment by anyone having permanent status in the competitive service; and

WHEREAS, the FY 2000-2001 Adopted Budget for the Year 'Round Food Service Program for Children includes funding for this contract; now therefore, be it

RESOLVED: That the City Manager or his designee as agent of the City of Oakland is hereby authorized and directed to submit on behalf of the City of Oakland an application to CNFDD for funds to operate a Year 'Round Food Service Program for Children in the City of Oakland from January 2,2000 through September 30,2001 and to execute and submit all documents, including but not limited to agreements, amendments, and payment requests which may be necessary to obtain funds to operate such a program and to accept said funds; and, be it further

RESOLVED: That the City Manager is hereby authorized and directed to appropriate any additional funding which may become available from this grant; and be it further

RESOLVED: That the City Council hereby authorizes the City Manager or his designee as an agent for the City to execute a Professional Services Contract between the City and the Oakland Unified School District in an amount not to exceed \$552,750 to provide food services; and, be it further

RESOLVED: That the sum of \$743,057 and offsetting revenue shall be appropriated to Fund 2159, Organization 78241, Project H93700 for the purpose of operating the Year 'Round Food Service Program for Children; and be it further

RESOLVED: That the City Manager is hereby authorized to approve any subsequent amendments to or extensions of said Professional Services Contract with the exception of an increase in compensation provided that such amendments or extensions shall be approved by the City Attorney's Office and shall be filed with the City Clerk's Office.
