Ordinance to Amend the City of Oakland's Conflict of Interest Code (Ordinance number 11562 C.M.S, as amended, Oakland Municipal Code Chapter 3.16.)

The City Council was advised in a letter from this office dated October 12, 2004, that the Political Reform Act, Government Code Section 87306.5, require every local government agency to review its conflict of interest code. Additionally, the local agency must report to its code review body every even numbered year on whether it is necessary either to amend the code or to report that no amendment is necessary.

The City Attorney has reviewed the City of Oakland's Conflict of Interest Code and determined that amendments are necessary. The code requires amending in the areas shown below.

- 1) Include new positions that must be designated.
- 2) Make changes to the positions assigned.
- 3) Revise the titles of existing positions.
- 4) Delete titles of positions that have been abolished.

Please note that the Chabot Space and Science Center is an agency whose jurisdiction is in more than one county (Alameda and Contra Costa). Therefore, it has been removed from the list of designated boards and commissions because the Fair Political Practices Commission (FPPC), serves as the code reviewing body pursuant to the Government Code Section below.

82011. "Code reviewing body" means all of the following:

(a) The commission [FPPC], with respect to the conflict-of-interest code of a state agency other than an agency in the judicial branch of government, or any local government agency with jurisdiction in more than one county.

Attached for your review and consideration is an ordinance that amends the Conflict of Interest Code (Oakland Municipal Code Chapter 3.16).

This office recommends that you adopt the attached ordinance.

WHEREAS, pursuant to the State of California Political Reform Act, the City of Oakland enacted Ordinance Number 11562 C.M.S. on March 23, 1993, enacting a conflict of interest code for City of Oakland employees, members of boards and commissions, and consultant positions;

WHEREAS, the Political Reform Act requires that every two (2) years in even numbered years, the code reviewing body review its conflict of interest code to determine whether it contains properly designated positions including employee positions, members of boards and commissions, and consultant positions; and

WHEREAS, the City Attorney recommends that City of Oakland Conflict of Interest Code, Oakland Municipal Code Chapter 3.16, be amended to include new positions which must be designated, make changes to the positions designated, revise titles of existing positions, departments, boards and commissions and delete titles of positions that have been abolished; and

WHEREAS, City of Oakland departments, boards, commissions and consultants have been notified that the Code has been reviewed; now therefore be it ordained:
