RESOLUTION HONORING DIAMANO COURA WEST AFRICAN DANCE COMPANY UPON THEIR 50TH ANNIVERSARY FOR OUTSTANDING SERVICE TO THE CITY OF OAKLAND THROUGH THE PRESENTATION OF TRADITIONAL WEST AFRICAN MUSIC, DANCE, THEATER, AND CULTURE

WHEREAS, Dr. Zakarya Sao Diouf and Naomi Gedo Diouf founded Diamano Coura West African Dance Company in 1975 to improve the presentation and teaching of African cultural traditions, naming their company in the Senegalese Wolof language with the meaning “those who bring the message;” and

WHEREAS, Diamano Coura West African Dance Company aims to combine rhythmic and movement dynamism to transport audiences into an understanding and appreciation of Africa's epic and folkloric culture; and

WHEREAS, March 7, 2015 was proclaimed “Diamano Coura West African Dance Company Day” by Mayoral Proclamation in recognition of the Company’s 20th Collage des Cultures Africaines, a four-day West African dance and drum conference and performance; and

WHEREAS, company founders Dr. Zakarya Sao Diouf and Naomi Gedo Diouf were awarded the National Heritage Fellowship from the National Endowment for the Arts in 2020; and

WHEREAS, Diamano Coura West African Dance Company’s programming, including the Collage de Cultures Africaines Conference, Arts-in-Education Program, and year-round performances have supported Oakland as a cultural destination for African Dance, attracting international recognition, artists, and audiences; and

WHEREAS, Diamano Coura West African Dance Company continues to explore and reconnect with the traditions, customs, and practices of their forebears so that they can revitalize and strengthen their cultural heritage, while also finding new ways to connect with the present and future; now, therefore, be it

RESOLVED: That the City of Oakland recognizes Diamano Coura West African Dance Company as a committed partner who looks to the inherent power of the arts to break barriers and create opportunities for social and economic development; and be it

FURTHER RESOLVED: That the City of Oakland graciously thanks Diamano Coura West African Dance Company founders, board, staff, and artists for their vision and leadership in helping to advance belonging, inclusion, and cultural expression for all Oaklanders.

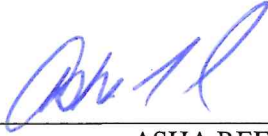
