RESOLUTION 1) AUTHORIZING THE CITY ADMINISTRATOR TO ENTER INTO AN AGREEMENT WITH CITY OF PIEDMONT TO RECEIVE ONE MILLION EIGHTY-TWO THOUSAND NINE HUNDRED FIFTY-FIVE DOLLARS AND NO CENTS (\$1,082,955) TO PROVIDE OAKLAND PUBLIC LIBRARY SERVICES TO PIEDMONT RESIDENTS FOR FISCAL YEARS 2025-2026, 2026-2027, AND 2027-2028; AND 2) ACCEPTING AND APPROPRIATING SAID FUNDS

WHEREAS, Piedmont residents receive library services from Oakland Public Library;
and

WHEREAS, the last agreement between the cities expired on June 30, 2008; and

WHEREAS, by declining to enter into this agreement, there would be no revenue to City of Oakland, nor savings for reduced services because of “universal borrowing” requirements under California state law; and

WHEREAS, Piedmont will pay the City of Oakland \$360,985 for Fiscal Year (FY) 2025-26, FY 2026-27, and FY 2027-28, for a total amount of \$1,082,955; and

WHEREAS, the revenue received shall be deposited into the City of Oakland General Purpose Fund (1010) in project numbers to be assigned; and

WHEREAS, section 504 of the Oakland City Charter provides that the City Administrator may negotiate contracts for joint governmental actions, subject to Council approval; now, therefore, be it

RESOLVED: That the City Administrator is hereby authorized to enter into an agreement with the City of Piedmont whereby Piedmont will provide the City of Oakland \$360,985 for FY 2025-26, \$360,985 for FY 2026-27, and \$360,985 for FY 2027-28, for a total amount of \$1,082,955 in order for the City to provide Oakland Public Library services to Piedmont residents through FY 2025-26, 2026-27, and 2027-2028; and be it

FURTHER RESOLVED: That said funds from the City of Piedmont are hereby accepted and will be appropriated in the General Purpose Fund (1010) in project numbers to be assigned.
