INTRODUCED BY THE CITY MANAGER

A RESOLUTION AUTHORIZING THE APPROPRIATION OF \$663,102 IN ADDITIONAL WORKFORCE INVESTMENT ACT FUNDING, AND AUTHORIZING AN ALLOCATION OF AN AMOUNT NOT TO EXCEED \$5,381,261 IN NEW WORKFORCE INVESTMENT ACT FUNDING TO THE OAKLAND PRIVATE INDUSTRY COUNCIL, INC., AND AN AMENDMENT TO THE MEMORANDUM OF UNDERSTANDING WITH THE OAKLAND PRIVATE INDUSTRY COUNCIL, INC. AS NEEDED TO EFFECTIVELY ADMINISTER SAID FUNDING FOR FISCAL YEAR 2003-2004

WHEREAS, the Oakland Workforce Investment Board (WIB) is required under the Workforce Investment Act of 1998 to approve all budgets related to the implementation of programs funded through the Workforce Investment Act; and

WHEREAS, the Policy Budget for FY 2003-2005 approved by the City Council contains an appropriation of \$5,542,050 to supplement \$175,642 in Workforce Investment Act funds carried forward from the FY 2002-2003 appropriation; and

WHEREAS, the City of Oakland's Workforce Investment Act (WIA) formula allocation is \$663,102 more than the \$5,542,050 appropriated in the City's FY 2003-2005 Policy Budget; and

WHEREAS, the Oakland Private Industry Council, Inc., serves as the Oakland WIB's program administrator and One Stop Career Center System operator; and

WHEREAS, the Memorandum of Understanding (MOU) between the City and the Oakland Private Industry Council, Inc., is effective until June 30, 2004, with terms that require approval of all references to the allocation of funding as part of the annual budget process; now, therefore, be it

RESOLVED: That the City Manager is authorized to appropriate \$663,102 in new Workforce Investment Act funding in addition to the \$5,542,050 appropriated in the FY 2003-2005 Policy Budget; and be it further

RESOLVED: That the City Manager is authorized to allocate an amount not to exceed \$5,381,261 in new WIA formula funds to the Oakland Private Industry Council, Inc., for fiscal year 2003-2004; and be it further

RESOLVED: That the City Manager is authorized to negotiate and enter into an amendment to the MOU between the City and the Oakland Private Industry Council, Inc. for fiscal year 2003-2004 as needed to effectively administer the WIA funds allocated by this Resolution; and be it further

RESOLVED: That the City Manager and his designee is hereby authorized to take whatever action is necessary with respect to said Workforce Investment Act and related funding and the MOU between the City and the Oakland Private Industry Council, Inc., consistent with this Resolution and its basic purposes.
