RE: A RESOLUTION FROM THE OAKLAND CITY COUNCIL SUPPORTING THE INSTALLATION OF A MURAL ALONG 52nd STREET AT THE HIGHWAY 24 UNDERPASS AND ASSUMING RESPONSIBILITY FOR ITS MAINTENANCE AND UPKEEP

SUMMARY

The Temescal Flows mural will be installed on 12 overpass support columns and two concrete fasciae of Highway 24 at the 52nd Street underpass between Shattuck Avenue and Martin Luther King Jr. Way in north Oakland. The project will create a pleasant gateway connector between Children's Hospital and the Temescal shopping district.

The mural project is sponsored by the Temescal-Telegraph Business Improvement District (**T**TBID). The artist, Alan Leon, was selected through an open competitive process conducted by the TTBID. He has worked closely with community members to create images for the 52nd Street mural. An illustration of the proposed mural is attached.

The site is owned by Caltrans, but access to the infrastructure will be across City of Oakland public right-of-way (sidewalks and streets). Caltrans requires a City resolution that provides that the City will be responsible for the maintenance of the mural. The City has signed an agreement with TTBID to cover installation and maintenance.

FISCAL IMPACT

The total project budget is \$90,436. The TTBID is providing \$70,438 toward the project. The City is contributing funds to cover a portion of the project budget, through a \$14,500 Public Art Program artwork commission as part of the Open Proposals Program, funded with a grant from the Open Circle Foundation, and a \$4,999 Individual Artist Project Grant from the Cultural Funding Program.

BACKGROUND

The Temescal area community and the Temescal Telegraph Business Improvement District have been working for several years to beautify the surrounding areas.

The project began as a concept in the community and was developed with community input. The TTBID initiated the design and selection competition and artist Alan Leon was selected.

KEY ISSUES

This mural project will transform a poorly lit and uninviting underpass into an attractive connector between Children's Hospital and the Temescal shopping district. The 52nd Street underpass is a well-used corridor. There are many pedestrians and cyclists who use the underpass everyday. In addition, the hospital employs 2,600 people many of whom walk through the underpass to get to Telegraph Ave. for breakfast, lunch or dinner.

There is full public access to the site since it is a public city street with sidewalks and 2-directional roadbeds.

The "Temescal Flows, Phase I" murals will illustrate the intersection of the natural and the built environments at this site by evoking in an abstract visual style the watershed and creek system (the natural history of this area) and punctuating the design with images of Temescal's people, pioneers, milestones and highlights (its human history). The design proposal by artist Alan Leon was selected through a competitive process by the TTBID and has been presented for review and comment at several community meetings in the Temescal neighborhood.

The City and the TTBID have entered into a contract for the TTBID to install and maintain the mural. The TTBID will be responsible for maintenance and graffiti removal.

The Public Art Advisory Committee and the Cultural Affairs Commission of the City of Oakland have reviewed and accepted the mural proposal.

RECOMMENDATION

It is recommended that the City Council pass the resolution.

A RESOLUTION FROM THE OAKLAND CITY COUNCIL SUPPORTING THE INSTALLATION OF A MURAL ALONG 52nd STREET AT THE HIGHWAY 24 UNDERPASS AND ASSUMING RESPONSIBILITY FOR ITS MAINTENANCE AND UPKEEP

WHEREAS, the Temescal area community and the Temescal Telegraph Business Improvement District (BID) have been working for several years to beautify the surrounding areas; and

WHEREAS, 52nd Street is a street under the jurisdiction of the City of Oakland and is a pedestrian access point to the Temescal Telegraph commercial corridor; and

WHEREAS, artist Alan Leon has worked closely with community members to create images for a mural to be painted on the underpass along 52nd Street; and

WHEREAS, the inclusion of public artwork has the potential to enliven and beautify the urban landscape of the Temescal/Telegraph area and to create a welcoming gateway to the district; and

WHEREAS, the proposed mural is funded by \$70,438 from the Temescal Telegraph BID, a \$14,500 Public Art Program artwork commission through the Open Proposals Program, and a \$4,999 Individual Artist Project Grant from the Cultural Funding Program, for a total of \$90,436; and

WHEREAS, the Public Art Advisory Committee and the Cultural Affairs Commission of the City of Oakland have reviewed and accepted the proposal by Alan Leon for the mural project on the underpass along 52nd Street; and

WHEREAS, as a condition to approving the installation of artwork on California Department of Transportation (Caltrans) facilities, Caltrans requires a resolution from the City Council that the City is responsible for maintenance and upkeep of artwork on Caltrans facilities; now, therefore be it

RESOLVED: that the Oakland City Council supports the installation of a mural along 52nd Street at the Highway 24 underpass and that the City's Cultural Arts and Marketing Division assumes responsibility for installation, traffic control, maintenance and upkeep, including removal, of the mural for its expected lifespan of 30 years.
