INTRODUCED BY COUNCILMEMBER _____

RESOLUTION TO SUPPORT PROPOSITION 1C, THE HOUSING AND EMERGENCY SHELTER TRUST FUND ACT OF 2006

WHEREAS, the provision of affordable housing is a high priority for the City of Oakland, as established in the Housing Element adopted in 2004 and the Consolidated Plan adopted in 2005; and

WHEREAS, the City's General Plan Land Use and Transportation Element supports the development of transit-oriented development; and

WHEREAS, in 2002, California voters adopted Proposition 46 to provide \$2.1 billion in State funding for affordable housing; and

WHEREAS, Oakland ranked third among all cities in the amount of Proposition 46 funds awarded for housing in the locality; and

WHEREAS, funding from Proposition 46 has been key to the City's progress in meeting its affordable housing goals; and

WHEREAS, Proposition 46 funds will be depleted by 2007; and

WHEREAS, to continue the successes of Proposition 46, the California Legislature has placed Proposition 1C, the Housing and Emergency Shelter Trust Fund Act of 2006, on the November ballot as part of a long-term plan to rebuild California; and

WHEREAS, Proposition 1C, the Housing and Emergency Shelter Trust Fund Act of 2006, will provide funding for the following programs:

- **Affordable Home Ownership Programs** - \$725 million to help over 23,600 families become or remain homeowners
- **Affordable Housing Construction Programs** - \$345 million for affordable rental housing for more than 4,000 families
- **Housing for Farmworkers** - \$135 million to build rental and home ownership opportunities to help farm workers

- **Homeless Permanent Housing Construction** - \$245 million to build permanent housing for the homeless, those transitioning out of homelessness and foster care youth
- **Homeless Shelter Housing Construction** - \$50 million to construct and expand homeless shelters of last resort and transitional housing for the homeless
- **Transit-Oriented Development** - \$300 million to develop and construct housing and infrastructure projects within close proximity to transit stations
- **Infill Housing Construction** - \$850 million in grants for development of public infrastructure projects that facilitate or support infill housing construction. Projects could include water, sewer and transportation improvements, traffic mitigation, brownfield clean up and up to an additional \$200 million for parks
- **Urban, Suburban and Rural Parks** - \$200 million; and

WHEREAS, Proposition will also boost California's and Oakland's economy, through new jobs and local spending; now, therefore, be it

RESOLVED, that the City Council of the City of Oakland hereby endorses Proposition 1C, The Housing and Emergency Shelter Trust Fund Act of 2006, and urges local voters to support the measure; and be it

FURTHER RESOLVED, that a copy of this resolution shall be sent to the Proposition 1C campaign to document the City's endorsement of the measure.


