**RESOLUTION AMENDING RESOLUTION NO. 88333 C.M.S. TO EXTEND THE GRANT AWARD TERM END DATE WITH S.A.V.E CENTER FOR COMMUNITY CHANGE AND EMPOWERMENT TO JUNE 30, 2022.**

**WHEREAS**, on August 13, 2019, the City Council adopted Resolution No. 87834 C.M.S., which, among other things, authorized the City Administrator to award a grant to and enter into a grant agreement with the S.A.V.E. Center for Community Change and Empowerment ("S.A.V.E.") for the period of July 1, 2019 to June 30, 2020, in an amount not to exceed \$350,000, to provide workforce development and employment placement for unhoused people in Oakland; and

**WHEREAS**, organizational changes precluded City staff from being able to execute the grant with S.A.V.E. within Fiscal Year 2019-2020, as originally authorized in Resolution No. 87834 C.M.S.; and

**WHEREAS**, on October 2, 2020, the City Council adopted Resolution No. 88333 which, among other things, amended Resolution No. 87834 C.M.S. to extend the grant award end date with S.A.V.E. to June 30, 2021; and

**WHEREAS**, it took until the beginning of the third quarter of Fiscal Year 2020-2021 before S.A.V.E. had fulfilled all City requirements, hired staff and participants, and began meeting the deliverables outlined in its scope of work; and

**WHEREAS**, S.A.V.E. has enrolled in the City's Strengthening Organizations to Address and End Homelessness in Oakland Capacity Building Project to increase its ability to deliver homeless services efficiently and effectively; and

**WHEREAS**, City staff is seeking the authority to extend the grant award term end date and agreement end date with S.A.V.E. from June 30, 2021 to June 30, 2022, in order to execute an agreement aligned with the Council's original intent; now, therefore, be it

**RESOLVED:** That Resolution No. 88333 C.M.S. is amended to extend the grant award term end date and authorizes the City Administrator to extend the grant agreement term end date with S.A.V.E. through June 30, 2022; and be it

**FURTHER RESOLVED:** That the City Administrator is authorized to conduct all negotiations; execute and submit all documents, including but not limited to applications, agreements, amendments, modifications, payment requests; and to take related actions necessary for the above-referenced agreement, without returning to Council; and be it

**FURTHER RESOLVED:** That said grant amendment shall be reviewed as to form and legality by the Office of the City Attorney and executed copies of the same shall be filed with the Office of the City Clerk.


