

## INTRODUCED BY COUNCILMEMBER ABEL GUILLÉN

### RESOLUTION AUTHORIZING COUNCILMEMBER ABEL GUILLEN TO TRAVEL TO LONG BEACH, CALIFORNIA TO ATTEND THE 2016 LEAGUE OF CALIFORNIA CITIES ANNUAL CONFERENCE & EXPO FROM OCTOBER 5-7, 2016

**WHEREAS**, Councilmember Abel Guillen, the City of Oakland's designated alternative voting delegate to the 2016 League of California Cities Annual Meeting taking place in Long Beach, CA, will represent the City of Oakland at the 2016 League of California Cities Annual Conference and Expo from October 5-7, 2015; and

**WHEREAS**, pursuant to City Council Resolution No. 82800 C.M.S. approved by Council on June 1, 2010, which establishes a policy that Councilmembers, when seeking Council approval for travel, shall indicate whether City funds will be used when travel involves airline transportation and lodging, and shall provide an estimate of the cost of airline, lodging, per diem and conference fees when City funds are used and the source of City funding that will be used to cover the travel costs; and

**WHEREAS**, in compliance with City Council Resolution No. 82800 C.M.S., the estimated cost of transportation is \$350 (air) and up to \$120 (ground); lodging is \$465.32; per diem is \$241.50; and conference registration fee is \$575.00; and

**WHEREAS**, in compliance with City Council Resolution No. 82800 C.M.S., the source of City funding that will be used to cover the travel costs will be from City Council Contingency Project funds; and

**WHEREAS**, Councilmember Guillen seeks Council approval of the aforementioned estimated costs to travel to Long Beach, CA to attend the 2016 League of California Cities Annual Conference and Expo, October 5-7, 2016; now, therefore, be it


**RESOLVED**: That all expenses incurred for said travel are hereby authorized.
