# OAKLAND CITY COUNCIL

RESOLUTION No. 88110 C.M.S.

---

**A RESOLUTION AUTHORIZING:**

- 1. THE CITY TO APPLY FOR, ACCEPT AND APPROPRIATE THE STATE PRE-KINDERGARTEN SUPPLEMENTAL GRANT IN AN AMOUNT OF \$32,500, AND THE STATE PRESCHOOL PROGRAM EXPANSION GRANT IN AN AMOUNT OF \$1,225,109, AND ANY SUCH ADDITIONAL GRANT FUNDING, FROM THE CALIFORNIA DEPARTMENT OF EDUCATION TO FUND PREKINDERGARTEN AND FAMILY LITERACY SERVICES FROM JULY 1, 2020 TO JUNE 30, 2021; AND**
- 2. A CONTRIBUTION FROM THE CITY'S GENERAL PURPOSE FUND EQUIVALENT TO CENTRAL SERVICES OVERHEAD COSTS ESTIMATED AT \$157,786**

**WHEREAS**, the City of Oakland (City) wishes to apply for, accept and appropriate a grant in an estimated amount of \$32,500 from the California Department of Education (CDE) to fund California Pre-Kindergarten Supplemental Program (CPKS) from July 1, 2020 to June 30, 2021; and

**WHEREAS**, the FY2019-2020 Midcycle Proposed Budget includes an appropriation of \$32,500 for the CPKS grant in the CDE Fund (2138), HS Classroom and Seasonal Org (78231), Head Start CSPP FY20-21 Project (1004511), and Strengthening Children, Youth & Families Program (YS13); and

**WHEREAS**, the City wishes to apply for, accept and appropriate a grant in an estimated amount of \$1,225,109 from the CDE to fund California State Preschool Program (CSPP) prekindergarten and family literacy services from July 1, 2020 to June 30, 2021; and

**WHEREAS**, the FY2020-21 Midcycle Proposed Budget includes an appropriation of \$1,225,109 for the CSPP grant in the CDE Fund (2138), HS Classroom and Seasonal Org (78231), Head Start CSPP FY20-21 Project (1004510), and Strengthening Children, Youth & Families Program (YS13); and

**WHEREAS**, these grant awards will be used to provide a prekindergarten and family literacy program in ten (10) Head Start/CSPP sites in Oakland; and

**WHEREAS**, the program will provide child development, parenting education and family literacy services to a total of 264 eligible three and four year-old children and their families; now, therefore, be it

**RESOLVED:** That the City, by and through the City Administrator or his designee, is hereby authorized to submit an application to the DOE, California Pre-Kindergarten Supplemental Program, for the CPKS grant for prekindergarten and family literacy services from July 1, 2020 through June 30, 2021, and the City hereby accepts and appropriates said funds in an estimated amount of \$32,500; and be it

**FURTHER RESOLVED:** That the City, by and through the City Administrator or his designee, is hereby authorized to submit an application to the DOE, California State Preschool Program, for the CSPP grant for prekindergarten and family literacy services from July 1, 2020 through June 30, 2021, and the City hereby accepts and appropriates said funds in an estimated amount of \$1,225,109; and be it

**FURTHER RESOLVED:** That all central services overhead charges associated with these grants in an estimated amount of \$157,786 shall be offset through a contribution of the City's General Purpose Fund due to administrative cost limitations; and be it

**FURTHER RESOLVED:** That should additional grant funds be received from the grantor (*i.e.*, CDE) for the same purposes within the existing grant term, the City hereby accepts and appropriates the grant funds without returning to Council within the duration of the July 1, 2020 – June 30, 2021 grant term; and be it

**FURTHER RESOLVED:** That the City Council hereby authorizes the City Administrator or his designee to conduct all negotiations, execute and submit all documents including but not limited to applications, agreements, amendments, modifications, payment requests, and to take all related actions which may be necessary to apply for, accept and appropriate the aforementioned grants; and be it

**FURTHER RESOLVED:** That all agreements and amendments, if any, authorized under this resolution shall be reviewed as to form and legality by the Office of the City Attorney and copies filed with the Office of the City Clerk.


