INTRODUCED BY COUNCILMEMBER JANANI RAMACHANDRAN

RESOLUTION AWARDING A GRANT AGREEMENT TO DIMOND IMPROVEMENT ASSOCIATION (DIA) FOR AN AMOUNT NOT TO EXCEED TWENTY-FIVE THOUSAND DOLLARS (\$25,000) TO SUPPORT BID FORMATION ACTIVITY PURSUANT TO COUNCIL RESOLUTION 88783 C.M.S.

WHEREAS, on July 26, 2021, the City Council passed Resolution No. 88783 C.M.S (Amending Resolution No. 88717 C.M.S., which adopted the Fiscal Year 2021-23 Biennial Budget) to, among other things, make a one-time appropriation of \$25,000 to pay for BID feasibility studies in commercial districts for Council Districts 4, 6 and 7 (Resolution No. 88783 C.M.S. (Minutes "Expenditure Additions (Positive #) GPF 1010 Amendments, Item #1)); and

WHEREAS, the Dimond Improvement Association (DIA) is a 501(c)(3) nonprofit organization (ID # 30-0590727) dedicated to making the City of Oakland's Dimond District, located in District 4, a vibrant, safe and beautiful place for the community to live, work, shop and play; and

WHEREAS, the City Council enacted the City of Oakland Business Improvement Management District Ordinance (BIMD Ordinance) pursuant to Ordinance No. 12190 C.M.S.(1999), as codified in chapter 4.48 of the Oakland Municipal Code (O.M.C.), establishing the procedures for the formation of business improvement management districts; and

WHEREAS, the DIA has invested in exploring the feasibility of the formation of a business improvement district (BID) for the Dimond District including retaining consultants to research and advise regarding the same and the Council wishes to support those efforts by awarding a grant agreement to DIA for that purpose; and

WHEREAS, the funds are available in General Purpose Fund (1010)/Economic Development Org (85411)/ Business Improvement District Project (1000147)/Business Attraction, Retention and Expansion Program (SC11); now therefore, be it

RESOLVED: That DIA is hereby awarded a grant agreement in an amount not to exceed Twenty-Five Thousand Dollars (\$25,000) to support its efforts to establish a Dimond District BID, including for BID feasibility studies; and be it

FURTHER RESOLVED: That the City Administrator is hereby authorized to negotiate and execute a grant agreement with DIA in an amount not to exceed Twenty-Five Thousand Dollars (\$25,000) and is authorized to modify, extend or amend the grant agreement without increasing the amount of the grant award.


