City of Oakland</u>, <u>et al.</u>, Alameda County Superior Court Case No. RG14732238, City Attorney's File No. 29938, for a sum not to exceed Two Hundred and Thirty Thousand Dollars and No Cents (\$230,000.00) payable by the City of Oakland; and be it

WHEREAS, Resolution No. 86329 C.M.S. provides that the sum of Two Hundred and Thirty Thousand Dollars and No Cents (\$230,000.00) be payable as follows: in the amount of One Hundred and Twenty-One Dollars and No Cents (\$121,000.00) payable to "Winer, McKenna, Burritt, LLP" and in the amount of One Hundred and Nine Thousand Dollars and No Cents (\$109,000.00) payable to "BARCO Assignments, Ltd."

**WHEREAS**, after Resolution No. 86329 C.M.S. was passed, the Department of Health Services submitted a lien for payment of medical expenses it paid on behalf of Plaintiff Jane Roe.
