Chairwoman Brooks and the Members of the Life Enrichment Committee:

The Oakland Youth Advisory Commission's Annual Report for the year 2013 is attached to inform the Life Enrichment Committee of the commission's activities for the past year. The Oakland Youth Advisory Commission reconvened after a year's hiatus and a two year hiatus from 2007-2009. This year was a great year in which we teamed the process, structure and functions of the Youth Commission, our role within City Government and the power of our voices as youth in this city.

The Oakland Youth Advisory Commission is a group up to 25 young people between the ages 13 to 21 who are nominated by City Council and appointed by the Mayor. The commission was created to advise City Officials about issues related to youth in the City of Oakland. Moreover, this body was created to ensure that City Officials make informed decisions and create progressive youth policy by hearing directly from youth in the respective Council District's throughout the city. The commission gives Oakland's youth a voice in governmental affairs. Since the welfare of our community will increasingly be in the hands of the generations to come, it is critical to allow this alternative and emcial perspective in the City's decision making process. Young people are the City's chief economic asset, most valuable resource and are key agents for social change, economic development and technological innovation. Furthermore, young people represent agents, beneficiaries and victims of major societal changes and it is critical that we be allowed full participation in the decision-making process and the building and designing of the future of our city.

As part of the Oakland City Charter and Ordinance 10545, 11058, 11461, & 11869, the Youth Commission has made and will continue to make a positive impact on the lives of our city's children and youth. The commission organized, supported and collaborated with various organizations on a number of exciting events, a Commercially Sexual and Exploited Children's Hearing and a Public Safety Town Hall that allowed youth to be involved in decisions that affect our everyday lives. The Oakland Youth Commission will remain dedicated to youth leadership, decision making, and empowerment and thank City Officials for the opportunity to be a part of the larger political and civic engagement process.

As the City of Oakland's youth representatives, the commission hopes to frequently collaborate and meet with the Mayor and City Council to review policies pertaining to youth, draft recommendations and provide input in 2014.

- · Reviewing requests made by the public and deciding what is best way lo move forward on that request as it relates safety and youth.

- The Environment & Sustainability Committee is a standing committee of the Youth Commission that serves as a forum to review and recommend environmental projects and sustainability initiatives, and addresses issues concerning public health and housing for Oakland Youth.

- · will provide cleaner and greener neighborhoods and housing
- that will provide equal access to quality physical, psychological, and emotional health care.
- Its goal is to make sure that all Oakland Youth are healthy, have access to quality health care, access to healthy food, access to decent housing and environmentally safe neighborhoods free of environmental hazards.

Top Concerns & Recommendations

Environment and Sustainability

- Create a committee to assess and address the needs of African American and Latino youth who are the most vulnerable and at risk populations in the City of Oakland. (Health, access to a equitable and quality education, housing disparities and living conditions, homicides, Disproportionate Minority Contact (DMC), juvenile delinquency, and unemployment).
- Create a public/private partnership via WIB to set aside funds for a One Stop Shop for YOUTH. The One Stop Shop would have and provide education, housing and health resources, employment services, include a computer center and graduation assistance services to assist YOUTH in the City of Oakland.

Education

 Conduct an Independent policy audit of the "push out policies" that force or cause students in Oakland to drop out.

Top Concerns & Recommendations

Public Safety

- Commercially Sexually Exploited Children (CSEC)

Economic Vitality and Employment

• Local Hire policy needs to include youth-10% of the 50% of jobs in the local hire policy should be set aside for youth between the ages of 16 and 26.

Resolution 001-2013 CSEC Awareness and Prevention

Resolution urges the City Council and Mayor in partnership with Oakland Unified School District, local law enforcement, the Department of Health and Human Services, and community-based organizations that work with children, youth and families to prioritize the development and institutionalization of a comprehensive prevention model to eliminate the commercial sexual exploitation of children in Oakland. (Resolution will be carried to Council by Councilmember Lynette McElhaney's Office)
