An Amount Not To Exceed Two Hundred Seventy-Five Thousand Dollars (\$275,000.00), Bringing The Total Contract Amount To Two Million Six Hundred Ninety-Seven Thousand Nine Hundred Eighty-Nine Dollars

(\$2,697,989.00)

#### **SUMMARY**

A resolution has been prepared waiving the competitive Request for Proposal/Qualification process and authorizing Amendment No. 4 to increase the professional services agreement with ELS Architecture and Urban Design for the East Oakland Sports Center Project (EOSC) for an amount not to exceed two hundred seventy-five thousand dollars (\$275,000.00), bringing the total contract amount to two million six hundred ninety-seven thousand nine hundred eighty-nine dollars (\$2,697,989.00).

The additional services will be utilized to provide construction support services, building commissioning services, and for contingencies for any unforeseen conditions that may occur during the construction phase. This cost increase is due to the added design services to complete construction documents for the fitness center and dance studio, added services associated with securing a Major Conditional Use Permit, developing contingency plans in the event that funding was not secured for the entire Phase 1 project and design services required for major utility relocation. Staff proceeded with the added design work in conjunction with the identification of the funding necessary to fully implement the Phase 1 project and to maintain the project schedule.

In February 2001, ELS was chosen through the City's Request-for-Proposal process as the top-rated and most qualified firm to provide comprehensive professional services associated with the design and construction of the East Oakland Sports Center. While additional project funds were being sought, Council authorized ELS to perform pre-design/programming, concept design work, schematic design, design development design, and construction document design under three previous contract amendments. Sufficient funding for the EOSC Phase 1 project was secured in November 2008. The construction document design work for the EOSC was completed in December 2008 and construction began in June 2009.

#### FISCAL IMPACT

Approval of this resolution will authorize the increase of the professional services agreement with ELS Architecture and Urban Design for the EOSC in an amount not to exceed \$275,000.00, for a total contract amount not to exceed \$2,697,989.00. Sufficient funding in the amount of \$275,000 for Amendment No. 4 with ELS is available within the following source: Measure I bond fund, Fund 5010, Organization 92270, Project No. C83213.

#### **BACKGROUND**

The concept for the EOSC originated prior to 1996 with visions to create a recreation complex with aquatics, fitness centers, gymnasiums, and other sports facilities that would serve the local community and be used as a venue for the possible 2012 San Francisco Bay Area Olympic Games. In 2001, ELS Architecture and Urban Design was chosen through the City's Request for Proposal process as the top-rated and most qualified firm to provide comprehensive professional services associated with design and construction of the EOSC. ELS provided a comprehensive fee proposal to provide master plans, schematic plans, construction documents, specifications, cost estimates, construction support, and fund raising assistance associated with the design and construction of the project. The estimated cost for the entire project was approximately \$36,000,000, however, only \$3,167,000 in Measure I funding was available at the time. Therefore, it was decided to design and construct the project in phases as funding became available. While additional funds were being sought, the following City Council actions regarding ELS design services approvals were made:

- Pursuant to Resolution No. 76278 C.M.S. dated February 13, 2001, the City entered into an agreement with ELS to provide pre-design/programming and concept design work with the intent and direction to return to Council for subsequent approval of the schematic design, design development, and construction document portions of the project.
- After completion of the pre-design/programming and concept design, the City Council
  approved Resolution No. 77071 C.M.S. on April 23, 2002, authorizing Amendment No. 1
  to the professional services agreement with ELS for the schematic design of the EOSC.
  In addition, Amendment No. 2 to the professional services agreement was executed in
  April 2004 to extend the duration of the contract.
- The City Council approved Resolution No. 77071 C.M.S. on July 3, 2007, authorizing Amendment No.3 to ELS's professional services agreement for the preparation of construction documents for the EOSC Phase 1 project. This action was motivated by the requirements of the State Proposition 40 grant which required completion of the project by March 2010.

The current total project funding for the EOSC is \$23,567,000. Initial funding was provided in 1997 with Measure I bonds in the amount of approximately \$3,167,000. In 2002, the Measure DD bond committed an additional \$10 million to the project, and in addition, staff was successful in securing a \$2.4 million State Proposition 40 Grant. In 2008, East Bay Regional Park District (EBRPD) Measure WW bonds provided an additional \$6 million to the project and \$2 million was added in Redevelopment Agency funds.

The construction phase of the EOSC project was on hold from December 2008 to June 2009 due to concerns about the availability of funding provided by future bond sales. The state Proposition 40 grant funding was frozen in December 2008 due to the state's budget issues. The hold on the grant funding was subsequently released in May 2009. Staff has requested an extension from state grant officials to the March 31, 2010, deadline for completing the EOSC project. Additionally, the sale of Measure DD Series B bonds was successfully completed in July 2009.

#### KEY ISSUES AND IMPACTS

Under the initial Request for Proposal/Qualifications process, ELS was deemed the most qualified firm to provide the professional design services for this project. Council has consistently supported the intent and direction to utilize ELS throughout the project and to incrementally approve segments of the design work. ELS is inherently familiar with the project, provides continuity, and can provide the necessary design services in an efficient and timely manner. Further, use of an additional Request for Proposal process to select another consultant or to utilize another consultant from the City's As-Needed consultant contracts would not allow the project to proceed in a timely fashion. ELS is the architect of record for the project and there are legal implications for changing architects at this stage of the project.

The City's Municipal Code, Title 2, Chapter 2.04.050 I (5) allows an exception to the advertised competitive bidding process when it has been determined that it is in the best interests of the City to waive the competitive Request for Proposals/Request for Qualifications selection requirement of Section 2.04.051 A of the Oakland Municipal Code.

This professional services cost increase is due to four major factors. These factors include an increase in the overall scope of the project over what was covered in the initial cost proposal, added design costs associated the Major Conditional Use Permit, development of contingency plans in the event that Measure WW was not approved, and the resolution of major utility relocation issues. Detailed descriptions of the circumstances of these cost increases are as follows:

Construction document design fees for fitness center and dance studio
 The construction document design phase project began as a \$16.5 million project and included potential bid alternate elements for the fitness center and dance studio. The full

Item: \_\_\_\_\_ Public Works Committee December 1, 2009 design of these alternates for construction would depend on the availability of funding based on the construction cost estimate developed at the design development phase. If funding was available for the fitness center and dance studio the full design would be done at extra cost. The estimate at the design development phase indicated that there was insufficient funding to build the fitness center and dance studio. Rather than eliminate the fitness center and the dance studio from the design, it was decided to complete design at increased cost and that additional construction funding to build these elements would be secured in the future. This additional funding was provided from the Oakland Redevelopment Agency and Regional Measure WW which brought the total project cost to about \$23.5 million.

#### • Major Conditional Use Permit

Professional services associated with providing information for planning permits was excluded from the consultant's scope of work because the extent of the process had not yet been determined nor had the need for the permit been confirmed. The Major Conditional Use Permit required numerous graphic exhibits, calculations and quantification of site elements and design analysis of the project. Extensive services from the consultant were required in order to secure approval of the Major Conditional Use Permit.

#### Contingency plans for reduced scope project

Additional design services were required to develop contingency plans to build a scaled down EOSC building in the event that Regional Measure WW was not approved by the voters in November 2008. The lack of funding would have required a \$6 million reduction in the construction budget. The driving force behind maintaining the schedule was the State Proposition 40 grant deadline which required the project to be completed by March 31, 2010.

#### • Utility relocation

During the design development phase, it was discovered that all the utilities for the Ira Jinkins Recreation Center were underground and passed through the foot print of the proposed EOSC building. These utilities needed to be relocated to allow construction of the new building. The design work, which was specifically excluded from the initial design proposal, involved extensive coordination with utility companies and coordination with the Oakland Fire Prevention Services for fire sprinkler service to the existing building.

Staff proceeded with the added design work in conjunction with Council's identification of the Measure WW and Redevelopment Agency funding (\$8 million) that was necessary to fully implement Phase 1 of the EOSC project. Also, the City was obligated to expedite the EOSC project and complete the work as soon as possible to comply with the Proposition 40 grant requirements.

Under Amendment No. 4, ELS will provide the remaining construction support and building commissioning necessary to complete the EOSC. The work includes reviewing and approving submittals and shop drawings, evaluating site and design changes, providing clarifications, coordinating the Leadership in Energy and Environmental Design (LEED) certification, and preparing final punch-lists for the project. The \$275,000 funding increase identified for Amendment No.4 will include a \$25,000 contingency for any further unforeseen, additional services required to complete the EOSC project.

ELS has met the Local/Small Local Business Enterprise requirements with an overall participation level of 21.41%. The design team includes the local firms of Telemon Engineering, Sandis Civil Engineering, SOHA Structural Engineering, H&M Mechanical, F.W. Associates, Cumming Corporation, Applied Materials and Keller Mitchell, Inc. The LBE/SLBE information has been verified by the Contract Compliance Division of the City Administrator's Office and is shown on *Attachment A*.

#### **EVALUATION OF PAST PERFORMANCE**

No Contractor Performance Evaluations are on file with the City for ELS Architecture and Urban Design at this time. ELS has not completed any City contracts which require such evaluation. The work to date performed by ELS on the EOSC has been satisfactory.


#### PROJECT DESCRIPTION

The EOSC will be constructed at 9175 Edes Avenue between Jones Avenue and Phelps Street at Bill Patterson Park (formerly named Brookfield Park). The project will include a total of 22,500 square feet of building floor space; 6,000 square feet on the upper level and 16,500 square feet at ground level. The building includes a 9,000 square foot indoor swimming pool building (natatorium) with a 3,500 square foot indoor recreational swimming pool, changing/locker rooms and rest rooms, a reception area with meeting rooms and offices, an aerobics/dance room, a multi-purpose room/learning center and a fitness center. An 85-space parking lot is also included.

#### SUSTAINABLE OPPORTUNITIES

*Economic*: The project will generate business tax, sales tax, and other revenues for the City by those firms who work on the project.

Environmental: Environmental factors and opportunities are being incorporated to the extent feasible. The consultants and contractor are required to achieve a LEED silver rating in the design and construction of the facility by maximizing recycled content materials in the products, waste reduction, energy conservation, and integrating other environmental opportunities. The



water for the recreational swimming pool will be heated by solar thermal panels mounted on the roof of the natatorium.

**Social Equity:** The EOSC will provide new social opportunities and services to the community with much needed aquatic and recreational facilities for all ages and abilities and will provide a venue for building community cohesiveness and community pride.

#### DISABILITY AND SENIOR CITIZEN ACCESS

The EOSC will be in full compliance with the physical access requirements of the Americans with Disabilities Act ("ADA") by providing equal access to the facility.

#### RECOMMENDATION AND RATIONALE

It is recommended that the City Council waive the competitive Request for Proposal/Qualifications process for professional services and authorize Amendment No. 4 to the professional services agreement with ELS Architecture and Urban Design, for the EOSC in an amount not to exceed \$275,000.00, for a total contract amount of \$2,697,989.00.

ELS was deemed the most qualified firm to provide the professional design services for this project under the initial Request for Proposal process and Council's intent and direction has been to utilize ELS throughout the entire project. ELS is inherently familiar with the project, provides continuity, and can provide the necessary design services in an efficient and timely manner.

#### ACTION REQUESTED OF THE CITY COUNCIL

Staff recommends that City Council approve the resolution.
