RESOLUTION APPOINTING COUNCIL PRESIDENT KEVIN JENKINS TO THE EXECUTIVE COMMITTEE OF THE EAST BAY ECONOMIC DEVELOPMENT ALLIANCE AND APPOINTING COUNCILMEMBER NOEL GALLO AS ALTERNATE MEMBER FOR A TWO-YEAR TERM COMMENCING JULY 1, 2024, AND ENDING JUNE 30, 2026

WHEREAS, the Bylaws of the East Bay Economic Development Alliance, Article IV, Section 4, The Executive Committee, state: "Public members are appointed by the Mayor's Conferences, Boards of Supervisors, and Special District Associations for Alameda and Contra Costa Counties; and

WHEREAS, Council President Kevin Jenkins recommends the appointment of himself to the Executive Committee of the East Bay Economic Development Alliance and recommends the appointment of Councilmember Noel Gallo as an alternate; now, therefore, be it

**RESOLVED:** That Council President Kevin Jenkins is hereby appointed to the East Bay Economic Development Alliance's Executive Committee, for the two-year term commencing July 1, 2024, and ending June 30, 2026; and be it

**FURTHER RESOLVED:** That Councilmember Noel Gallo is hereby appointed as alternate to the East Bay Economic Development Alliance's Executive Committee, for the two-year term commencing July 1, 2024, and ending June 30, 2026.
