INTRODUCED BY COUNCILMEMBER DESLEY BROOKS

RESOLUTION AUTHORIZING USE OF PAY GO IN THE AMOUNT OF TEN THOUSAND DOLLARS (\$10,000.00) FOR POLICE SERVICES AT THE SO YOU THINK YOU CAN HOOP 3 ON 3 BASKETBALL COMPETITION AT THE ORACLE ARENA JULY 19TH AND 20TH, 2008

WHEREAS, on July 17, 2007, the City Council revised the pay go procedures to pre-approve use of pay-go for City of Oakland infrastructure, furniture or equipment expenditures, or to grants to other government agencies for infrastructure, furniture or equipment expenditures; and

WHEREAS, City Council approval is required for use of pay go for purchase of non-infrastructure services; and

WHEREAS, a community 3 on 3 Basketball Competition will be held at the Oracle Arena on July 19th and 20, 2008 and to assure the safety of participants and attendees Oakland Police Officers will provide security at the event; and

WHEREAS, Councilmember Desley Brooks wishes to use ten thousand dollars (\$10,000.00) of her pay-go funds to pay for Police services at the 3 on 3 competition; and

WHEREAS, pay go funded purchases are subject to City of Oakland purchasing procedures including bid procedures under Oakland Municipal Code Section 2.04.050, but purchases of professional, technical or scientific services are exempt from competitive such bidding requirements under 2.04.050.1.1; and

WHEREAS, this contract is of a professional, scientific or technical and temporary nature, shall not result in the loss of employment or salary by any person having permanent status in the competitive service, and is not subject to the City's request for proposal requirements in Oakland Municipal Code Section 2.04.051.A because it is less than twenty five thousand dollars; now, therefore, be it

RESOLVED: That the City Council authorizes the use of Councilmember Brooks' pay go funds in the amount of ten thousand dollars (\$10,000.00) for the purchase of Police services from the Oakland Police Department for the 3 on 3 Basketball Competition at the Oracle Arena on July 19th and 20th, 2008.
