## OAKLAND CITY COUNCIL

RESOLUTION NO. 90579 C.M.S.

A RESOLUTION AMENDING RESOLUTION NO. 90310 C.M.S., WHICH AWARDED OAKLAND FUND FOR CHILDREN AND YOUTH GRANTS FOR FISCAL YEAR 2024-2025, TO AMEND THE FOLLOWING GRANTEES TO REFLECT LEAD AGENCY PROGRAMMATIC CHANGES WITHOUT CHANGE TO THE GRANT AMOUNTS:

- 1) REPLACE JEWISH FAMILY & COMMUNITY SERVICES EAST BAY WITH LINCOLN FOR EARLY CHILDHOOD MENTAL HEALTH COLLABORATIVE SERVICES;
- 2) UPDATE "TO BE DETERMINED BY OUSD" WITH SAFE PASSAGES FOR EAST OAKLAND PRIDE ELEMENTARY;
- 3) UPDATE "TO BE DETERMINED" WITH DREAM YOUTH CLINIC FOR DREAMCATCHER YOUTH PROGRAM; AND
- 4) AMEND THE NAME OF GENESYS WORKS BAY AREA TO GENESYS WORKS FOR PATHWAYS TO COLLEGE AND CAREER SUCCESS FOR OAKLAND'S HIGH SCHOOL STUDENTS.

**WHEREAS**, the Kids First! Oakland Fund for Children and Youth (OFCY) was established by voter-approved ballot Measure K in 1996 to set aside funds for program and services benefiting children and youth; and

**WHEREAS**, the OFCY was extended for twelve years (12) by voter approval in 2009 (Measure D); and

**WHEREAS**, pursuant to the authority the City of Oakland Charter section 1307, City Council adopted Ordinance No. 13588 C.M.S. on March 3, 2020, which extended the OFCY an additional twelve (12) years, beginning July 1, 2021, and continuing through June 30, 2033; and

**WHEREAS**, the Planning and Oversight Committee (POC) was established pursuant to Measure K to provide oversight and direction of the OFCY planning and funding review process; and

**WHEREAS**, in January 2022, OFCY released the 2022-2025 Request for Proposals (RFP) to solicit program proposals from non-profit organizations and public agencies; and

**WHEREAS**, in May 2024, City Council adopted Resolution No. 90310 C.M.S. awarding OFCY grants for FY 24-25, after which OFCY was informed of programmatic and other changes to grant awards at certain locations; and

**WHEREAS**, Oakland Unified School District (OUSD) school site leadership made the decision to remove Jewish Family Community Services and replace with Lincoln to provide mental health consultation for children and their families; and

**WHEREAS**, OUSD school site leadership also made the decision to remove Higher Ground and replace with Safe Passages to provide academic and social-emotional support, enrichment, youth development/leadership, recreation, fitness, and family engagement to target population to youth attending East Oakland Pride Elementary School; and

**WHEREAS**, Covenant House declined the OFYC funding for FY 24-25 and OFCY staff recommend replacement with the subgrantee Dream Youth Clinic to provide Dream Youth Catcher trauma informed, positive youth development activities to unaccompanied minors and homeless youth exposed to violence and trafficking in Oakland; and

**WHEREAS**, Genesys Works Bay Area changed their legal name to Genesys Work, and will continue to provide pathways to college and career success for Oakland's high school students; and

**WHEREAS**, all of the substituted organizations participated in an open and fair application process to receive OFCY funding; and

**WHEREAS**, on October 16, 2024, the POC unanimously approved the substitutions and programmatic changes as reflected in Table 1 below and is submitting the changes to City Council for approval; now, therefore, be it

**RESOLVED:** That Resolution No. 90310 C.M.S. is hereby amended as to change the grantees pursuant to Table 1 below and for public record of the ultimate grantees;


