Pursuant to Section 401 of the Charter, the City Attorney has prepared a resolution and recommends settlement of the above-entitled matter. This matter was presented in Closed Session on December 8, 2009.

Due to the potential for a higher award from the jury and/or Court, settlement is recommended of the above-captioned action on the following terms:

- Each of the currently employed plaintiff officers will receive 130 hours of special leave, to be distributed over three years, that cannot be cashed out unless an employee's service terminates.
- The plaintiffs who have retired as of the effective date of the settlement will each receive \$3,500.
- Each currently employed plaintiff who terminates employment prior to February 1, 2012 will receive 50% of the dollar equivalent of his/her special leave.
- One Million, Seven Hundred Fifty Thousand Dollars, and No Cents (\$1,750,000), for attorneys' fees and costs will be paid to Rains Lucia Stern,PC and Aitchison Vick, plaintiffs' attorneys of record.

FURTHER RESOLVED: That the plaintiffs who remain employed by the City will receive 130 hours of special leave, to be distributed over three years, that cannot be cashed out unless an employee's service terminates.

FURTHER RESOLVED: That the plaintiffs who have already retired will each receive a cash payment of \$3,500.

FURTHER RESOLVED: That a currently employed plaintiff who terminates employment prior to February 1, 2012 will receive 50% of the dollar equivalent value of his or her special leave.

FURTHER RESOLVED: That the sum of ONE MILLION SEVEN HUNDRED FIFTY THOUSAND DOLLARS in attorneys' fees and costs (\$1,750,000) will be paid to Rains Lucia Stern, PC and Aitchison Vick, plaintiffs' attorneys of record.
