CITY OF OAKLAND, PIEDMONT GROCERY STORE, MARK SMITH, 4038 PIEDMONT AVENUE, LLC, AND DOES 1 THROUGH 50, INCLUSIVE, ALAMEDA COUNTY SUPERIOR COURT CASE NO. 23CV057157, CITY ATTORNEY FILE NO. 36405, BY PAYMENT IN THE AMOUNT OF ONE HUNDRED AND SIXTY-SIX THOUSAND SIX HUNDRED AND SIXTY-SIX DOLLARS AND SIXTY-SEVEN CENTS (\$166,666.67) (DEPARTMENT OF TRANSPORTATION – DANGEROUS CONDITION)

WHEREAS, Plaintiff Louella Santobello ("Santobello") alleges that on April 5, 2023, Santobello sustained physical injury as a result of tripping over an uplift on the public sidewalk; and

WHEREAS, the City received prior complaints about the uplift, which was likely caused by a nearby City tree; and

WHEREAS, Santobello allegedly suffered a fractured left elbow, damaged jawbone and chipped front teeth, and underwent surgery for the injuries; and

WHEREAS, Santobello filed the lawsuit entitled Louella Santobello v. City of Oakland, Piedmont Grocery Store, Mark Smith, 4038 Piedmont Avenue, LLC, and DOES 1-50, Alameda County Superior Court Case No. 23CV057157, alleging negligence and dangerous condition of public property; and

WHEREAS, the City has considered all the evidence, litigation costs, and litigation risks in this case; and

WHEREAS, the City has determined that it is in the City's best interest to settle this lawsuit without admitting liability or wrongdoing and to avoid further litigation; and

WHEREAS, the parties and their legal counsel have negotiated a fair and reasonable settlement of these claims; now, therefore, be it

RESOLVED: That the City Attorney is authorized and directed to compromise and settle the case of *Louella Santobello v. City of Oakland, Piedmont Grocery Store, Mark Smith, 4038 Piedmont Avenue, LLC, and DOES 1-50*, Alameda County Superior Court Case No. 23CV057157, for the sum of One Hundred and Sixty-Six Thousand Six Hundred and Sixty-Six Dollars and Sixty-Seven Cents (\$166,666.67); and be it

FURTHER RESOLVED: That the City Attorney is authorized and directed to take whatever steps as may be necessary to effect said settlement.
