Pursuant to Section 401 of the Charter, the City Attorney has prepared and recommends settlement of the above-entitled case for the sum of \$12,500.00, payable to Kristine McCabe and her attorney, Joel H. Siegal, as a result of a trip and fall accident on August 13, 2009. The incident occurred in a marked crosswalk at a state highway off-ramp and co-defendant CalTrans is contributing an additional \$ 162,500 to the total settlement.

The settlement is recommended to avoid the risk of a much larger jury verdict should the matter proceed to trial. This was not a closed session item.
