INFORMATION

The purpose of this Information Memorandum is to provide an update on the State Budget and its potential impact on the City of Oakland's budget, as well as provide a brief summary of the most recent Oversight Board hearing that occurred on June 4.

On Friday afternoon, after relatively short Floor Sessions, both Houses of the Legislature approved the main Budget Bill, in compliance with Proposition 25, which requires a budget to be sent to the Governor by June 15. They also passed six other budget-related trailer bills, out of approximately 29 in total.

Many of the remaining trailer bills are still being negotiated with the Governor, but are expected to be passed by the end of the month. Governor Brown has not clarified whether he will support the bills approved today, but State Treasurer Bill Lockyer released a statement that the budget is "financeable" as passed by the Legislature. With the exception of the main budget bill, the other bills will not likely be sent to the Governor for consideration until all of the remaining trailer bills have been approved.

There has still not been any additional information released regarding the language of the trailer bill that addresses redevelopment issues. This remains a very active negotiation between the Legislature and the Governor's Office. In addition, the City has received no further or specific communication from the State Controller's Office related to the generic clawback order of April 20, 2012.

BACKGROUND

In January, the FY 2012-13 Governor's Budget projected that the state needed to address a budget problem of \$9.2 billion in order to balance the FY 2012-13 General Fund budget. Spring tax collections showed that the estimates included in the Governor's budget were too optimistic

about tax revenues, and required state expenditures on schools under current law and tax policies also are estimated to be higher. In total, the administration's estimate of the size of the budget problem increased by \$6.5 billion between January and May to now total \$15.7 billion.

As part of his May Revision, the Governor has proposed an overall budget architecture for FY 2012-13 that relies on state revenues that would be raised only if approved by voters in November 2012. The November ballot will contain revised temporary tax initiative with lower sales and use tax (SUT) rates and higher personal income tax (PIT) rates on higher-income Californians.

The California Constitution requires that the annual state budget be balanced, and this uncertainty requires that the Legislature adopt contingency plans for addressing the \$8.5 billion in revenue that would not be raised if the revenues are not approved by the voters. The Governor has proposed "trigger reductions" effective January 1, 2013 that would be the contingency plan if the ballot measures are not approved.

The Figure below shows the Governor's updated trigger cut proposal to take effect if voters reject the proposed tax measure in November.

In addition, the May Revision assumes K-14 districts will receive a total of \$3.3 billion in the current and budget year from the dissolution of Redevelopment Agencies (RDA). This amount includes (1) \$1.8 billion in RDA property tax revenues (down from \$2.1 billion assumed in the January budget) and (2) \$1.5 billion in RDA cash and other liquid assets (a new budget solution in the May Revision).

For the City of Oakland, this additional transfer of unencumbered Low/Mod Funds is estimated to equate to about \$7-15 million.
