RESOLUTION NO. 90421 C.M.S.

A RESOLUTION ACCEPTING THE POLICE COMMISSION SELECTION PANEL'S SLATE OF TWO COMMISSIONERS, ANGELA JACKSON-CASTAIN AND SAMUEL DAWIT, TO SERVE ON THE OAKLAND POLICE COMMISSION

WHEREAS, Oakland voters approved Measure LL – establishing a Police Commission on November 8, 2016 with 83.19% in favor of the measure; and

WHEREAS, Measure LL established City Charter Section 604 which created a seven-member Police Commission to oversee the Oakland Police Department's policies and procedures; and

WHEREAS, City Charter Section 604(c)(2) requires the Mayor to appoint three Oakland residents as regular members to the Police Commission and one Oakland resident as an alternate member; and

WHEREAS, City Charter Section 604(c)(3) established a nine-member Selection Panel to select candidates for the remaining four positions on the Police Commission,

WHEREAS, under City Charter Section 604(c)(3) the Selection Panel is to review, interview and select candidates for the Police Commission's four full time commission positions, and one alternate position, and submit its slate to the City Council for approval;

WHEREAS, the Selection Panel's one regular commissioners have terms set to expire on October 16, 2024 and Selection Panel nominee that resigned on June 30, 2024;

WHEREAS, during its 2024 selection process, the Selection Panel sought applicants, interviewed six (6) candidates through two rounds of interviews, and selected two individuals as its nominees for the Police Commission;

WHEREAS, Section 604(c)(3) of the City Charter provides City Council with the authority to accept or reject the Selection Panel's appointments to the Police Commission; now therefore, be it

RESOLVED, That pursuant to City Charter Sections 604(c)(3), the City Council hereby accepts the following Selection Panel's slate of candidates in its entirety to serve as members of the Police Commission as follows:

Samuel Dawit (Full Commissioner) Term: October 17, 2024 – October 16, 2026

Angela Jackson-Castain (Full Commissioner) Term: October 17, 2024 – October 16, 2027


