# A RESOLUTION CONFIRMING THE MAYOR'S APPOINTMENT OF RAVAHN SAMATI TO THE HOUSING, RESIDENTIAL RENT AND RELOCATION BOARD AS AN UNDESIGNATED MEMBER

WHEREAS, Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

WHEREAS, Ordinance No. 11954 C.M.S., adopted December 17, 1996, and amended from time to time, including most recently by Ordinance No. 13828 CMS, created the Housing, Residential Rent and Relocation Board ("Board") to assume all duties and functions heretofore exercised by the Housing Advisory and Appeals Board, Relocation Appeals Board, and the Housing Advisory and Appeals Board; and

WHEREAS, the Board consists of seven (7) members, two tenants, two landlords, and three undesignated members, serving not more than two consecutive three-year staggered terms and two alternates for each of the three classes of members; and

WHEREAS, the Honorable Mayor Kevin Jenkins has appointed Ravahn Samati to serve a three-year term subject to confirmation by the City Council; now, therefore, be it
