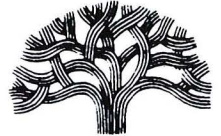

RESOLUTION AUTHORIZING AND DIRECTING THE CITY ATTORNEY TO COMPROMISE AND SETTLE THE CLAIM OF PACIFIC GAS & ELECTRIC COMPANY, IN THE AMOUNT OF EIGHT THOUSAND THREE HUNDRED TEN DOLLARS AND 72/100 CENTS (\$8,310.72) AS THE RESULT OF DAMAGES SUSTAINED FROM A CONSTRUCTION EVENT ON OCTOBER 18, 2014 (OAKLAND PUBLIC WORKS—PROPERTY DAMAGE)

WHEREAS, claimant alleges that on October 18, 2014, it sustained damages as a result of a construction event; and

WHEREAS, the claimant filed the above entitled claim seeking payment for said damages; and

WHEREAS, the City of Oakland has determined that settlement in this amount, without an admission of liability, is in the best interest of the City; now therefore, be it

RESOLVED: That the City Attorney is authorized and directed to settle the claim of Pacific Gas & Electric Company, our file number C30545, in the amount of Eight Thousand Three Hundred Ten Dollars and 72/100 Cents (\$8,310.72); and be it

FURTHER RESOLVED: That the City Attorney is further authorized and directed to take whatever steps may be necessary to effect said settlement; and be it

FURTHER RESOLVED: That the sum of Eight Thousand Three Hundred Ten Dollars and 72/100 Cents (\$8,310.72), be made payable to Pacific Gas & Electric Company.
