Subject: Shovel Ready Projects from Councilmember Quan

At the January 12 Budget Retreat a call was put out for Infrastructure Projects for the Obama Economic Stimulus Program that had gone beyond the design phase and were ready for implementation, these to be discussed at the January 20, 2009 City Council Meeting.

I would like to propose the following additional projects:

- 1) <u>City of Oakland Safe Walks to School Projects</u> such as a pedestrian path linking Joaquin Miller school with surrounding neighborhoods that allows students to avoid the heavy traffic of Mountain and Ascot Boulevards and which has been designed by City Staff.
- 2) <u>City of Oakland Bicycle Projects</u> such as
  - a. A bicycle path starting from the Glenview neighborhood and running up Park Boulevard to Mountain Boulevard which has been fully designed,
  - b. A combined bicycle and pedestrian path that links Mills College and the Maxwell Park neighborhood that has been designed but lacks implementation funding.
- 3) City of Oakland Teen Centers such as the Brookdale Teen Center
- 4) <u>Projects associated with Chabot Space and Science Center</u> that have been designed but lack implementation funding. These are:
  - a. An outdoor camp/class room teaching facility
  - b. A Global Warming Exhibit currently in the design phase
  - c. The extension of the telescope viewing platform.
- 5) A city-wide residential earthquake retrofitting program designed to prevent a Katrina scale disaster in Oakland, with a Job Training component similar to the Green Building Program.

- 6) A city-wide vegetation management program in conjunction with the Wildfire Prevention Program which would include a specific program designed to protect the endangered Pallid Manzanita while clearing areas of brush and other fire hazards.
- 7) <u>Various Improvements to Head Start Centers</u> including new construction, necessary repairs, and new playground development, which would also reinstate field trips and restore personnel cuts eliminated during the budget cycles of 05/07 and 08/09.
