RESOLUTION AUTHORIZING THE CITY MANAGER TO EXTEND THE TERM OF THE PROFESSIONAL SERVICE CONTRACT FOR REAL-TIME CLOSED CAPTIONING STENOGRPAHY SERVICES WITH JANE JAMES DBA CAPTIONING AGENCY PROFESSIONALS FOR 90 DAYS (JULY, SEPTEMBER, OCTOBER 2003) FOR AN AMOUNT NOT TO EXCEED FIFTY THOUSAND DOLLARS (\$50,000).

WHEREAS, the City of Oakland intends to extend the term of the professional services contract for real-time closed captioning services with Jane James DBA Captioning Agency Professionals for Council meetings during the period of July 1, 2003 through October 31, 2003 (excluding the month of August 2003 due to City Council recess); and

WHEREAS, the Agreement is required due to the requirements of the Americans with Disabilities Act (ADA) 42 U.S.C. § 12101 <u>et seq.</u> and Administrative Instruction No. 123, the City's Access Policy; and

WHEREAS, the City Council finds that the service is professional; and

WHEREAS, the City Council finds that the service is temporary for the period of July 1, 2003 through October 31, 2003 excluding the month of August 2003 due to City Council recess); and

WHEREAS, the City Council finds that the contract shall not result in the loss of salary or employment by any person having permanent status in the competitive service; and

WHEREAS, the City Oakland desires that Jane James DBA Captioning Agency Professionals provide the required services to the City of Oakland during City Council, Committee/Council meetings and all special meetings of the City Council; and therefore, be it

RESOLVED: that the City Manager is authorized to extend the agreement between Jane James DBA Captioning Agency Professionals and the City of Oakland to provide closed captioning services during City Council meetings, City Council Committee Meetings, and all special meetings of the City Council for the period from July 1, 2003 through October 31, 2003; be it

FURTHER RESOLVED: that the City Attorney shall review and approve as to form and legality all documentation with respect to this Agreement.
