INTRODUCED BY MAYOR BARBARA LEE

A RESOLUTION CONFIRMING THE MAYOR'S APPOINTMENT OF BRIAN HOLLANDER AND KEANA GILES TO THE COMMISSION ON PERSONS WITH DISABILITIES

WHEREAS, Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

WHEREAS, Ordinance No. 9968 C.M.S., adopted August 5, 1980, and amended by Ordinance No. 11864 C.M.S., adopted March 12, 1996 and then by Ordinance No. 13334 C.M.S., adopted October 20, 2015, created the Commission on Persons with Disabilities to address issues germane to accessibility, services and civil rights for persons with disabilities; and

WHEREAS, the Commission on Persons with Disabilities consists of eleven (11) members, serving three-year staggered terms with no more than two consecutive terms; and

WHEREAS, at least a majority of the Commission members appointed must be persons with disabilities; and

WHEREAS, the Honorable Mayor Barbara Lee has appointed Brian Hollander and Keana Giles to the Commission on Persons with Disabilities, subject to confirmation by the City Council; now, therefore, be it

RESOLVED: That pursuant to City Charter Section 601, the City Council hereby confirms the Mayor's appointment to the Commission on Persons with Disabilities:

Brian Hollander, to serve a three-year term beginning September 3, 2024 and ending September 2, 2027, filling a vacant seat previously held by Ravin Foote.

Keana Giles, to serve a three-year term beginning September 3, 2024 and ending September 2, 2027, filling a vacant seat previously held by Kaitlin Roh.


