RECOMMENDATION

Staff Recommends That The City Council Receive An Informational Report From The Oakland Cultural Affairs Division On The Status Of Its FY 2023-24 Operations.

REASON FOR SUPPLEMENTAL

At the May 14, 2024 Life Enrichment Committee meeting, the Committee requested additional details regarding payment status of Fiscal Year (FY) 2023-24 Cultural Funding Grants, including Cultural Organization Assistance (General Operating), Neighborhood Voices for Festivals and Networks of Care: Teaching Artist Support Grants. The additional details requested include the names of the organizations and the status of each delayed contract (e.g., pending, executed, and paid). If the contract is pending, a note indicating why it is still pending is to be included. If the contract has been executed but is not yet paid, an estimate of the date of payment is provided, and if the contract is paid, the date is provided.

Attachment A provides an update on all of delayed Cultural Funding Grants, including the status of the contract execution; the name of the organizations awarded contracts; and the time for executing said contracts, what date it was executed and paid.

BACKGROUND

The Cultural Funding Program was established by the City Council in 1985 as the City's mechanism to support Oakland-based nonprofit arts and cultural organizations through an annual competitive application process. These grants infuse Oakland's neighborhoods with arts and cultural activities that increase exposure to, understanding of, and respect for diverse cultural heritages, support arts activities that engage the community, and support hands-on arts

instruction in Oakland's public schools. In the past five years, the Cultural Funding Program has awarded an average of \$1.4M each year to Oakland artists and arts organizations.

For FY 2023-24, the Cultural Funding Program provided grants in three categories:

<u>Cultural Organizational Assistance (Two Year Grant)</u> provides general operating support to established, primary arts organizations. To be eligible, an organization must have received Cultural Funding Program funding in two of the past four consecutive funding cycles.

<u>Neighborhood Voices for Festivals</u> builds belonging within the dynamic neighborhoods of the City by supporting culturally engaging efforts to bring our community members together through festival culture. Festivals to be supported may include, but are not limited to: block parties, parades, performances in poetry, dance, music or theater, visual art, and literary presentations, that are rooted in a sense of place.

Networks of Care: Teaching Artist Support Grants provides organizations funding for Teaching Artists conducting arts instruction for Oakland youth. The program awards grants of \$10,000 to Oakland-based non-profit organizations to supplement current teaching artist salaries, and/or provide them with professional development opportunities to advance how we care for ourselves, and one another.

Cultural Funding Application Process

To ensure transparency and public trust in the distribution of public funds for the arts in Oakland, the program has established policies, review procedures, and a panel system for evaluating applications.

The Cultural Funding Program staff strive to have a diverse team of community members to serve as panelists - representing various ages, backgrounds, races, ethnicities, sexual orientations, and professions to help City staff evaluate each grant category. The grant review panelists have been selected for their expertise relevant to each grant category. Cultural Funding Staff have a panelist application accessibly year-round on the City's website for interest community members to apply.

Grant applicants receive the biographies of each panelist the day prior to the public review panels. Biographies of panelists are also posted on the City's website for the general public. As part of the review process, applicants have the opportunity to address the panel for three-minutes. Oakland's Cultural Funding Program is one of the only local grant-making agencies in the State that allows applicants to address the community peer reviewed panel. The applicant's three-minute address is used to clarify any questions or misinterpretations that the applicant may have heard during the panel discussion.

Panelists thoroughly discuss, evaluate and score each proposal based on established criteria. In broad terms, the criteria for the panel review are: (1) Programmatic Impact: soundness of applicant's curriculum for arts instruction and potential for program to build social connection; (2) Cultural & Racial Equity: the extent to which the applicant's activities includes groups and communities impacted by racial and economic disparities; (3) Finance & Management: soundness of budget and qualifications of key personnel to execute planned programming.

Upon completion of the review process and ranking of the applications, staff determined a cutoff for grant awards and the allocation of funds. Applicants receiving an average score lower than 70 (from a possible 100 points) were automatically disqualified from funding. These funding allocations are based on the highest overall scores, and the amount of funding we have available. Staff review scores and ranking of the applicants, creating a list of recommended awards for Council consideration and approval.

Contracting Process

During the time period in which the recommended awards are being presented to City Council for review, the recommended grantees are invited to attend contracting webinars conducted by staff. These webinars familiarize organizations with the City's contracting process, including an overview of (1) insurance requirements, (2) schedules, (3) preparing scopes of work and budget, (4) business tax certificates, and (5) the grant agreements. Staff hold one-on-one meetings with grantees to support them through the contracting process and help them understand the City's requirements.

Grantees are notified that the time for contract execution varies significantly. This timeline can be highly impacted by the need to obtain the required insurance documents. However, after insurance is approved, the time for contract execution on average takes 8-12 weeks. A summary

of the process is as follows:



Grant Period Changes

Historically, the Cultural Funding Program has funded organization's activities for an entire fiscal year, July 1st through June 30th. However, this has meant that by the time grant recommendations are presented to City Council, typically in November/December, many events such as festivals have already taken place.

In January 2024, the Risk Division informed Cultural Affairs staff that they would no longer be approving insurance for festivals or other grantee events/programs that have already passed. To ensure that Risk review and contract execution occurs prior to events taking place, Cultural Affairs is changing its grant period from the fiscal year to the calendar year, January through December. This will allow staff to conduct the application process and present grant recommendations to City Council before the grant period has begun. For FY 2024-25, this also means that festivals occurring between July 1 through December 31, 2024 will not be financially supported by Cultural Affairs while staff aligns the process with the new schedule. This realignment will not affect awards already approved by City Council.

Staff have consulted with the City Attorney's Office, City Administrators Office, Risk Management Division and the Finance Department on these planned changes.

Art & Soul Festival

Art & Soul was approved for a \$20,000 grant on December 19, 2023 per Resolution No. 90058 C.M.S. to support the festival held in September 2023. Because Art & Soul was one of the many

festivals that had already occurred by the time the contract process began, staff needed to approach the City Administrator for special approval to proceed, as Risk was no longer reviewing or approving insurance for festivals that had already occurred.

Cultural Affairs staff collected all insurance documents from impacted festivals from January - February 2024, and began the process of drafting an insurance waiver for CAO's approval on February 20, 2024. CAO provided the insurance waiver for all impacted organizations to proceed on March 29, 2024. Art & Soul's contract was forwarded to Contract Compliance for execution on April 9, 2024.

ANALYSIS

On December 19, 2023 City Council approved the 60 grant recommendations to support arts and cultural organizations and festivals per Resolution No. 90058 C.M.S.

As of the May 14, 2024 Life Enrichment Committee Meeting, 42 grants had not yet been paid. These grants are listed in **Attachment A**.

Contract Processing Update

On May 15, 2024, the City Administrators Office announced that all approved grants for FY 2023-24 will be processed as planned, which had an immediate impact of contract processing. Of the 42 grants that were delayed, 21 have been executed and paid (or have payment in process), and 21 are still pending.
