**RESOLVED:** That the City Attorney is authorized and directed to compromise and settle claims of twenty-four (24) of the fifty-eight (58) plaintiffs in the matters of Port Local 10 Warehouse and Longshoremen et al. v. City of Oakland, et al., United States District Court Case No. C03-2962 TEH(JL) and Sri Louise Coles et al. v. City of Oakland et al., United States District Court Case No. C03-2961 TEH, for a sum not to exceed a total of One Hundred Forty-Five Thousand Dollars and No Cents (\$145,000.00). One check in the amount of Seventy Thousand Dollars and No Cents (\$70,000.00) as payment in full for the fourteen (14) plaintiffs settling for \$5,000.00 each and a second check in the amount of Seventy-Five Thousand Dollars and No Cents (\$75,000.00) as payment in full for the ten (10) plaintiffs settling for \$7,500.00 each. The two checks are to be made payable by the City of Oakland to James B. Chanin, Trustee.
