

Resolution Authorizing The City Administrator To Accept And Appropriate An Additional \$5,400,000.00 Of Fiscal Year 2007-08 Proposition 1B Transportation

Funds For Local Street And Road Rehabilitation

#### **SUMMARY**

A resolution has been prepared authorizing the City Administrator, or her designee, to accept and appropriate an additional \$5.4 million of Proposition 1B Funds in fiscal year 2007-08 for local street and road rehabilitation. As part of the adopted budget for fiscal year 2007-09, the City Council appropriated \$1.3 million for fiscal year 2007-08 of Proposition 1B Funds. Approval of the resolution will accept and appropriate an additional \$5.4 million for a total fiscal year 2007-08 appropriation of \$6.7 million of Proposition 1B Funds.

The work to be funded is located in all Council Districts as shown in Attachments A and B, and includes street resurfacing, traffic and bike lane striping, curb, gutter, sidewalk, and curb ramp repair. We anticipate that 80% of the funds will go towards rehabilitation of streets selected from the City's 5-Year Paving Plan. This policy and the list of streets were adopted by City Council in November 2007. The remaining 20% of the funds will go towards rehabilitation of the City's worst streets. The final list of streets for rehabilitation will be drafted after coordination with city and utility company projects.

Staff requests that the Council adopt the resolution.

#### FISCAL IMPACTS

Approval of this resolution will authorize the City Administrator to accept and appropriate an additional \$5.4 million of Proposition 1B Funds (FY 07-08). These funds will be placed in the following project accounts:

 Proposition 1B California Transportion Bond (2165); Engineering Design: Construction Services Organization (92232); Street Construction Account (57411); Project C317610; \$5,400,000.00.

Proposition 1B funds appropriated in fiscal year 2007-08 must be expended by June 30, 2011.

### **BACKGROUND**

In November 2006, California voters passed Proposition 1B which authorized \$19.9 billion in new state transportation bonds. This measure required the bond revenues to be invested in improving local streets, roads, and/or other priority local transportation projects. Eligible projects for Proposition 1B are those that reduce congestion, increase traffic safety, or rehabilitate and maintain local roads.

About \$13.4 million of Proposition 1B funds are allocated for the City of Oakland, specifically for local street and road repair. The original legislation anticipated that this funding would be available over a ten-year period. It was revised following successful lobbying by cities and counties to "front load" the funding, and 50% is available this year. Approximately half of Oakland's Proposition 1B funds (\$6.7 million) will be allocated in the fiscal year 07-08. During the fiscal year 2007-09 budget process, the City Council authorized and appropriated \$1.3 million of Proposition 1B funds for fiscal year 2007-08. Approval of the resolution will appropriate an additional \$5.4 million for a total appropriation of \$6.7 million for fiscal year 2007-08. The legislature and governor will decide in future budget cycles how quickly to disburse the remaining balance of \$6.7 million for a total Proposition 1B allocation of \$13.4 million.

Prior to receiving an allocation of funds from the Controller in a fiscal year, Oakland must submit to the State Department of Finance a list of projects expected to be funded with bond funds pursuant to an adopted city budget. The list of projects expected to be funded with bond funds shall include a description and the location of the proposed project, a proposed schedule for the project's completion, and the estimated useful life of the improvement. The list of projects is included as Attachments A and B. Action on this resolution is required to access these funds.

#### KEY ISSUES AND IMPACTS

At a workshop in fall 2007, staff presented a status report on the condition of Oakland's street network. Based on the City's most recent street condition survey, the Oakland's average Pavement Condition Index (PCI) is about 63 (on a scale of 0-100; 100 is for brand new pavement, 0 is for completely failed pavement). It was noted that the City will need about \$30 million per year just to maintain the pavement at the current condition.

Following the workshop, Council adopted a pavement prioritization policy with two key elements:

- Adopt a priority list (5 Year Paving Plan) of streets to be resurfaced as funds become available;
- Set aside 20% of pavement rehabilitation funds to be used on the "worst streets".

The list of streets in Attachment A is based on the 5 Year Paving Plan adopted by Council in fall 2007. Under the policy, 80% or \$5.36 million of the funds will be allocated to streets in Attachment A. The list of streets in Attachment B is based on resurfacing requests from residents, Council office requests, PWA Call-Center requests, and PWA Infrastructure Maintenance referrals. All streets in Attachment B have a PCI of 39 or less, and are considered the "worst streets." Under the policy, 20% or \$1.34 million of the funds will be allocated to streets in Attachment B in consultation with Councilmembers.

This project, when completed, will have numerous benefits such as:

- Decreasing the number of hazardous conditions on the City's streets and sidewalks
- Reducing the City's backlog of curb ramps that do not meet Americans with Disabilities Act (ADA) requirements
- Improving the City's street infrastructure
- Improving access for pedestrians, bicyclists, and those with physical disabilities

#### SUSTAINABLE OPPORTUNITIES

**Economic:** The street rehabilitation program reduces the City's municipal liability resulting from dangerous conditions that may result in accidents and injuries. Routine maintenance to the City streets enhances and protects the City's infrastructure. Street repair and rehabilitation contracts create job opportunities for local contractors.

All public works contracts require the payment of prevailing wage rates. Prevailing wages offer a livable wage for workers and contribute to an improved quality of life.

*Environmental*: Recyclable materials will be used within the concrete and asphalt concrete construction materials to the extent possible. Grindings from the asphalt paving will be recycled whenever possible. In addition, the improved pavement surface will make walking and bicycling easier and thus encourage residents to walk and use bicycles more and drive less, thereby helping to reduce air pollution and traffic congestion.

**Social Equity:** The street rehabilitation program works to preserve the City's infrastructure, enhance public access and protect the public from hazardous conditions. The Pavement

Item: \_\_\_\_\_ Public Works Committee May 13, 2008 Management Program ensures that street rehabilitation funds are spent in a manner that is equitable throughout the city.

### DISABILITY AND SENIOR CITIZEN ACCESS

The primary objective of street rehabilitation is to provide a well-maintained and safe path of travel and reduce the backlog of non-ADA compliant curb ramps for all travelers, including motor vehicles, pedestrians, bicyclists, and people with mobility impairments.

Street resurfacing eliminates potholes and provides a uniform travel surface for all roadway users, including pedestrians using crosswalks and transit vehicles.

#### RECOMMENDATION AND RATIONALE

Staff recommends Council approve the resolution authorizing acceptance and appropriation of an additional \$5,400,000.00 for a total fiscal year 2007-08 appropriation of \$6,700,000.00 of Proposition 1B Funds for local street and road rehabilitation.

These funds will reduce Oakland's backlog of deferred street maintenance by resurfacing streets. repairing sidewalks, and replacing curb ramps to meet ADA requirements.

### ACTION REQUESTED OF THE CITY COUNCIL

Staff recommends that the City Council approve the resolution.

RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO ACCEPT AND APPROPRIATE AN ADDITIONAL \$5,400,000.00 OF FISCAL YEAR 2007-08 PROPOSITION 1B TRANSPORTATION FUNDS FOR LOCAL STREET AND ROAD REHABILITATION

WHEREAS, the City of Oakland's streets infrastructure is considered a significant asset that impacts the quality of life for those who live and work in Oakland; and

WHEREAS, the City of Oakland is on an 80-year paving cycle rather than the industry-recommended 30-year paving cycle; and

WHEREAS, the City's Pavement Management Program has recommended a five-year \$30 million annual budget to maintain the current pavement condition; and

WHEREAS, State of California voters passed Proposition 1B in new state transportation bonds in November 2006; and

WHEREAS, about \$13.4 million of these bonds are allocated for the City of Oakland, and about half of Oakland's Proposition 1B funds (\$6,700,000.00) will be allocated in fiscal year 07-08; and

WHEREAS, the Proposition 1B bond revenues must be invested in improving local streets, roads, and/or other priority local transportation projects; and

WHEREAS, eligible projects for Proposition 1B are those that reduce congestion, increase traffic safety, or rehabilitate and maintain local roads; and

WHEREAS, the City Council recently adopted a 5-Year Paving Plan for FY 07-12, representing the optimized distribution of paving funds as analyzed by the City's Pavement Management Program; and

WHEREAS, the projects associated with the 5-Year Paving Plan for FY 07-12 are eligible for the Proposition 1B Funds; and

WHEREAS, 80% of funds will go toward rehabilitation of streets identified in the 5-Year Paving Plan for FY 07-12 and the remaining 20% of funds will go toward rehabilitation of "worst streets"; and

WHEREAS, the City of Oakland coordinates and screens all proposed streets for conflicts with sewer, storm drainage, gas, water, electrical, cable, and fiber optic replacement projects to insure that all underground rehabilitation work occurs prior to scheduled street rehabilitation projects; and

WHEREAS, the City Council appropriated \$1.3 million for fiscal year 2007-08 of Proposition 1B funds as part of the adopted budget for fiscal year 2007-09; now, therefore, be it

**RESOLVED:** That the City Administrator, or her designee, is authorized on behalf of the City of Oakland, to execute and submit all documents, payment requests and related actions, as well as, to accept and appropriate an additional \$5,400,000.00 for a total fiscal year 2007-08 appropriation of \$6,700,000.00 of Proposition 1B revenues for local street and road rehabilitation; and be it

FURTHER RESOLVED: That these funds will be placed in the following project accounts:

 Proposition 1B California Transportion Bond (2165); Engineering Design: Construction Services Organization (92232); Street Construction Account (57411); Project C317610; \$5,400,000.00.
