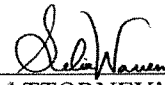

**RESOLUTION ACCEPTING AND APPROPRIATING GRANT FUNDS FROM THE CALIFORNIA BOARD OF STATE AND COMMUNITY CORRECTIONS IN THE AMOUNT OF THIRTY-ONE THOUSAND DOLLARS (\$31,000) TO SUPPORT THE MAYOR'S REGIONAL GUN VIOLENCE ROUNDTABLE ON OCTOBER 17, 2025**

**WHEREAS**, the City of Oakland has identified reduction of gun violence and enhancement of regional collaboration as urgent public safety priorities; and

**WHEREAS**, the California Board of State and Community Corrections (BSCC) has awarded the City a grant in the amount of **Thirty-One Thousand Dollars (\$31,000)** to support the Mayor's Regional Gun Violence Roundtable scheduled for October 17, 2025; and

**WHEREAS**, the purpose of the Roundtable is to convene regional mayors, law enforcement, public health, community-based organizations, and civic leaders to share strategies, coordinate interventions, and advance regional solutions to reduce gun violence; and

**WHEREAS**, the grant funds shall be maintained in Fund 2152 – California Board of Corrections, in the Project (TBD); now, therefore, be it

**RESOLVED:** That the City Council hereby accepts and appropriates grant funds in the amount of Thirty-One Thousand Dollars (\$31,000) from the California Board of State and Community Corrections to support the Regional Gun Violence Roundtable scheduled for October 17, 2025; and be it

**FURTHER RESOLVED:** That the City Administrator is authorized to enter into any agreement required by the California Board of State and Community Corrections to facilitate the City's receipt of the grant funds consistent with the purpose of this Resolution, and to take all actions necessary for full implementation of the grant.
