


Oakland Safety Facilities Plan

The Oakland Safety Facilities Plan Resolution

Authorizing the City Administrator to negotiate improvements to existing safety facilities and acquire and develop new ones. The City can significantly improve public services and facilities and the well-being of our community.



- This resolution builds upon prior legislation and plans, and staff and consultant recommendations, to pursue efficient methods for public facilities.
- •By relocating uses to better locations, it also allows for important revitalization of the existing site at Broadway and 6th St, connecting downtown, waterfront, Chinatown, old Oakland and more.



New Sites To Develop

A new State-of-the-art Crime lab, and 911 communications dispatch (With high-speed data access, uninterruptible power supply), at West Oakland BART, Mandela Station



New Site To Develop

New multi-agency Training facilities, including a driver training course, 360degree state-of-the-art training range, and education and meeting facilities in the Coliseum area.

 EOC (emergency operations center)






Existing Sites To Improve City Hall Plaza improve use and space of existing OPD office in City Hall Plaza

The West Oakland BART Project/Mandela Site


The West Oakland/Mandela Project will include modern public facilities and construct mixed-use buildings for commercial and residential purposes at a major transit hub in the heart of the region.

A new state-of-theart crime lab and communications dispatch center near the West Oakland BART station as a new site to develop.




By investing in new crime-solving technology & space, Oakland can better analyze evidence and solve crimes, and improve conditions for our workforce and the public.






In 2022, the City Council authorized the City Administrator to issue a Notice of Development Opportunity (NODO) seeking developers to develop mixed-use buildings and infrastructure at the PAB site.

The legislation cited the necessity of developing and revitalizing the PAB site. As noted in the legislation, the area is in the perfect position to "activate downtown Oakland."





The Coliseum Area

Has been approved for mixed-use development, and can also house new multi-agency training facilities, including a driver training course, education and meeting facilities, records, CORE academy, public permits and information, and related public functions.

Effective Funding Options, including Public-Private Partnerships

As recommended by a recent administration and consultant report, "A lease-back financing structure under which a facility could be built and financed by a private party to the City's specifications, with the financing secured by the City's long-term lease of that facility. This would allow the City to avoid taking on the large up-front debt required by traditional strategies" Allowing multiple options to fund and deliver projects.



Investing in the revitalization of Oakland's public facilities will improve municipal services for the public. Investing in crime lab improvements, 911 dispatch, multi-departmental crisis safety training, fire prevention, driver safety training, accident prevention, and disaster preparedness will also allow us to improve conditions for the public and the workforce, better use public resources, reduce vulnerability to disasters, and save time, money, and resources for the City and the public.
