RESOLUTION ESTABLISHING A MORATORIUM ON EVENT TABLE PURCHASES AND AUTHORIZING A CITY DEPARTMENT OR AGENCY TO PURCHASE A MAXIMUM OF THREE INDIVIDUAL TICKETS FOR AN EVENT UNLESS THE CITY ADMINISTRATOR APPROVES THE PURCHASE OF ADDITIONAL INDIVIDUAL TICKETS

WHEREAS, on September 23, 2008, the City Council's Finance and Management Committee received an informational report regarding the tables for events ("event tables") that were purchased by various City departments and agencies during the period of July 1, 2007 through June 30, 2008; and

WHEREAS, the City is facing a significant budget deficit; and

WHEREAS, given the City's budget deficit, the City Council of the City of Oakland finds that it is prudent and fiscally responsible to adopt a City policy that establishes a moratorium on event table purchases until such time as the Council either ends the moratorium or approves policies for the approval of event table purchases; NOW THEREFORE, be it

RESOLVED: that the City Council of the City of Oakland hereby adopts a budget policy establishing a moratorium on the purchase of event tables by the City's various departments and agencies; and be it

FURTHER RESOLVED: that the moratorium shall take effect immediately; and be it

FURTHER RESOLVED: that the City Administrator is directed to submit to the Council a report recommending policies to approve the purchase of event tables; and be it

FURTHER RESOLVED: that the moratorium shall remain in effect until such time as the Council either ends the moratorium or approves policies regarding the purchase of event tables; and be it

FURTHER RESOLVED: that notwithstanding the moratorium on the purchase of event tables, the Council also adopts the budget policy that each department or agency may purchase a maximum of three individual tickets for an event, and that any additional individual ticket purchases must be approved by the City Administrator; and be it

FURTHER RESOLVED: that any such expenditure must be for a public purpose and not otherwise prohibited by law.
