INTRODUCED BY COUNCILMEMBER CAMPBELL WASHINGTON

**RESOLUTION AUTHORIZING A GRANT OF \$2500 FROM COUNCILMEMBER CAMPBELL WASHINGTON'S GRAFFITI ABATEMENT MURAL AND GREEN WALL FUNDS TO THE LAUREL DISTRICT ASSOCIATION FOR THE MURAL AT 4255 MACARTHUR BOULEVARD IN OAKLAND**

**WHEREAS**, on June 27, 2013, the City Council adopted a budget that set aside Graffiti abatement funds for murals and green walls in the amount of \$50,000 for each council member to use in order to address graffiti within their districts, subject to Council approval; and

**WHEREAS**, the wall at 4255 MacArthur Boulevard is currently in a state of graffiti blight; and

**WHEREAS**, Councilmember Campbell Washington wishes to grant a portion of her Graffiti Abatement Mural and Green Wall Funds to the Laurel District Association for the mural at 4255 MacArthur Boulevard to beautify the culturally rich neighborhood, as well as to abate and deter graffiti; and

**WHEREAS**, in conformance with City requirements the Laurel District Association will provide documentation for the use of the Councilmembers Graffiti Abatement Mural and Green Wall funds, including any permits required and permission from the property owner of the proposed mural site; now, therefore, be it

**RESOLVED**, that the City Council authorizes a grant not to exceed \$2500 from Councilmember Campbell Washington's Graffiti Abatement Mural and Green Wall funds to the Laurel District Association for the mural at 4255 MacArthur Boulevard; and be it
