Resolution Authorizing the City Administrator to Apply for, Accept, and Appropriate up to Four Hundred and Fifteen Thousand Dollars (\$415,000.00) in FY 2010-11 State Transportation Development Act Article 3 Funds as Follows: (1) Ardley Avenue/16<sup>th</sup> Avenue Bikeway (MacArthur Boulevard to Embarcadero), Ninety Thousand Dollars (\$90,000.00); (2) Bicycle Detection at Actuated Traffic Signals, One Hundred Thousand Dollars (\$100,000.00); (3) Castlemont Stairs Rehabilitation (MacArthur Boulevard to Thermal Street), One Hundred Thousand Dollars (\$100,000.00); (4) CityRacks VIII Bicycle Parking Project, Seventy-Five Thousand Dollars (\$75,000.00); and (5) School Safety Improvements at Various Locations, Fifty Thousand Dollars (\$50,000.00)

### **SUMMARY**

A resolution has been prepared authorizing the City Administrator, or his designee, to apply for, accept, and appropriate up to \$415,000.00 in State Transportation Development Act (TDA) Article 3 Funds for the following five (5) bicycle and pedestrian projects:

## FISCAL IMPACT

Approval of this resolution will authorize the City Administrator to apply for, accept, and appropriate up to \$415,000.00 in State FY 2010-11 TDA Article 3 Funds. No matching funds are required to receive TDA Article 3 Funds, which must be expended within three (3) years of allocation.

Funds for the Ardley Avenue/16<sup>th</sup> Avenue Bikeway (MacArthur Boulevard to Embarcadero), will be deposited into the Transportation Development Act (TDA) Article 3 Fund (2162), Traffic Engineering Organization (92246), Street Construction Account (57411), and a new project number to be established.

Funds for Bicycle Detection at Actuated Traffic Signals will be deposited into the Transportation Development Act (TDA) Article 3 Fund (2162), Capital Projects—Electrical Projects Organization (92228), Electrical and Plumbing Supplies Account (52511), and a new project number to be established.

Funds for the Castlemont Stairs Rehabilitation (MacArthur Boulevard to Thermal Street) will be deposited into the Transportation Development Act (TDA) Article 3 Fund (2162), Capital Projects—Streets and Structures Organization (92242), Street Construction Account (57411), and a new project number to be established. The grant funds will be combined with \$100,000.00 from Measure B Bicycle/Pedestrian Pass-Thru Fund (2212), Capital Projects—Streets and Structures Organization (92242), Street Construction Account (57411), Capital Improvement Program — Pedestrian Streetscape Program FY 09-10 (C371710) for a total project budget of \$200,000.00.

Funds for CityRacks VIII Bicycle Parking Project will be deposited into the Transportation Development Act (TDA) Article 3 Fund (2162), Traffic Engineering Organization (92246), Supplies and Equipment Account (52920), and a new project number to be established.

Funds for School Safety Improvements at Various Locations will be deposited into the Transportation Development Act (TDA) Article 3 Fund (2162), Traffic Engineering Organization (92246), Street Construction Account (57411), and a new project number to be established.

## BACKGROUND

TDA Article 3 Funds are available from the Metropolitan Transportation Commission (MTC) for bicycle and pedestrian capital improvement projects. As required by the MTC, staff has determined that (a) there are no legal impediments or other factors that would affect the City's ability to deliver the projects; (b) sufficient staff resources and funding are available to complete the projects; and (c) there are no environmental or right-of-way issues that would jeopardize fund obligation deadlines. The five projects meet MTC's criteria for eligibility, including review by Oakland's Bicycle and Pedestrian Advisory Committee (BPAC). The BPAC reviewed the recommended allocations of TDA funds at its meetings in January 2010 and March 2010. The findings must be adopted by the City Council and are included in *Exhibit A* ("Findings"), pages A1 to A5 to the resolution.

## **KEY ISSUES AND IMPACTS**

Adoption of this resolution will allow the City to complete its applications for TDA Article 3 funding by the grant deadline of May 21, 2010. Construction of bicycle and pedestrian facilities is consistent with the goals of the City of Oakland's General Plan, the Bicycle Master Plan, and the Pedestrian Master Plan. The selection of projects is consistent with the Council-adopted criteria set forth in the Resolution Establishing Prioritization Methods for the City of Oakland's Facilities and Structures, Parks and Open Space, Sewers, Storm Drains, Street, Sidewalks, and Traffic Improvement Infrastructure Needs (Resolution No. 78747 C.M.S., adopted July 20, 2004). All five projects were further prioritized for funding based on readiness for construction.

For environmental clearance under the California Environmental Quality Act (CEQA), the City is relying on the previously certified and adopted Environmental Impact Report for the Bicycle Master Plan (2007) for the following projects: Ardley Avenue/16th Avenue Bikeway (MacArthur Boulevard to Embarcadero), Bicycle Detection at Actuated Traffic Signals, and CityRacks VIII Bicycle Parking Project. On a separate and independent basis, the following projects are exempt from CEQA pursuant to CEQA Guidelines Sections 15061(b)(3), 15301(c), 15301(f), and/or 15304(h): Ardley Avenue/16th Avenue Bikeway (MacArthur Boulevard to Embarcadero), Bicycle Detection at Actuated Traffic Signals, Castlemont Stairs Rehabilitation (MacArthur Boulevard to Thermal Street), CityRacks VIII Bicycle Parking Project, and School Safety Improvements at Various Locations.

## PROJECT DESCRIPTION

- Ardley Avenue/16<sup>th</sup> Avenue Bikeway (MacArthur Boulevard to Embarcadero) will connect the existing bikeway on Embarcadero, part of the San Francisco Bay Trail, to a bikeway on MacArthur Boulevard (scheduled for construction in 2010). The Ardley Avenue/16<sup>th</sup> Avenue bikeway will include a combination of bikeway striping and signage along 16<sup>th</sup> Avenue (Embarcadero to East 21<sup>st</sup> Street), East 21<sup>st</sup> Street (14<sup>th</sup> Avenue to 23<sup>rd</sup> Avenue), 21<sup>st</sup> Avenue (East 21<sup>st</sup> Street to East 30<sup>th</sup> Street), East 30<sup>th</sup> Street (21<sup>st</sup> Avenue to 23<sup>rd</sup> Avenue), 23<sup>rd</sup> Avenue (East 30<sup>th</sup> Street to East 31<sup>st</sup> Street), and Ardley Avenue (East 31<sup>st</sup> Street to MacArthur Boulevard). The project is located in City Council Districts 2 and 5, and it is a priority in the City's Bicycle Master Plan.
- Bicycle Detection at Actuated Traffic Signals will upgrade traffic signals to detect bicyclists by replacing deficient in-pavement loop detectors with video cameras. Locations will be identified citywide with priority given to intersections on existing bikeways and bikeways pending construction. This project will help the City comply with recent state legislation that requires all new or retrofit actuated traffic signals to detect bicyclists.
- Castlemont Stairs Rehabilitation (MacArthur Boulevard to Thermal Street) will replace missing handrails and repair damaged concrete stairs and landings to improve pedestrian

access to Castlemont High School and upgrade an emergency evacuation route from the adjoining neighborhood. The project is located in City Council District 7, and it was prioritized based on a recently completed citywide survey of Oakland's walkways.

- CityRacks VIII Bicycle Parking Project will respond to ongoing public requests for installing bicycle parking. It will also fund a pilot project to install "on-street" bicycle parking, bicycle racks located in the carriageway, for providing additional bicycle parking in commercial districts with limited sidewalk space. The project will install racks in commercial districts citywide, and it is a priority in the City's Bicycle Master Plan.
- School Safety Improvements at Various Locations will install low-cost treatments (e.g., striping and signs) at locations identified and prioritized in collaboration with TransForm's Safe Routes to School Program. Specific improvements will be identified through walk audits completed at individual schools by TransForm in cooperation with school staff, parents, and students. The project will make improvements at schools citywide, a policy priority in the City's Pedestrian Master Plan.

## SUSTAINABLE OPPORTUNITIES.

*Economic*: Bicycle and pedestrian facilities promote bicycling and walking, the most cost-effective forms of transportation. Bicycle and walking trips tend to be local and thus are more likely to contribute to local economic activity.

**Environmental**: Bicycling is the most energy efficient form of transportation and both bicycling and walking create no emissions, contributing to the City's efforts to reduce air pollution and address climate change. Bicycle parking racks are made from recycled steel, which produces fewer pollutants and preserves limited natural resources.

**Social Equity**: The projects improve accessibility and safety for persons who depend on non-motorized transportation and public transit to access jobs, services, and recreational facilities. Bicycling and walking are inexpensive and broadly accessible forms of transportation.

## DISABILITY AND SENIOR CITIZEN ACCESS

The Castlemont Stairs Rehabilitation will improve access for senior citizens and persons with disabilities by installing handrails and ensuring level walking surfaces. The School Safety Improvements at Various Locations will include pedestrian crossing improvements.

## RECOMMENDATION(S) AND RATIONALE

Staff recommends that the City Council authorize the City Administrator, or his designee, to apply for, accept, and appropriate up to \$415,000.00 in State Transportation Development Act

(TDA) Article 3 Funds for the following five (5) bicycle and pedestrian projects: (1) Ardley Avenue/16<sup>th</sup> Avenue Bikeway (MacArthur Boulevard to Embarcadero), Ninety Thousand Dollars (\$90,000.00); (2) Bicycle Detection at Actuated Traffic Signals, One Hundred Thousand Dollars (\$100,000.00); (3) Castlemont Stairs Rehabilitation (MacArthur Boulevard to Thermal Street), One Hundred Thousand Dollars (\$100,000.00); (4) CityRacks VIII Bicycle Parking Project, Seventy-Five Thousand Dollars (\$75,000.00); and (5) School Safety Improvements at Various Locations, Fifty Thousand Dollars (\$50,000.00). The grant funds will allow the City to implement priority projects and policies identified by the Pedestrian Master Plan and Bicycle Master Plan.

RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO APPLY FOR, ACCEPT, AND APPROPRIATE UP TO FOUR HUNDRED AND FIFTEEN THOUSAND DOLLARS (\$415,000.00) IN FY 2010-11 STATE TRANSPORTATION DEVELOPMENT ACT ARTICLE 3 FUNDS AS **FOLLOWS:** (1) **ARDLEY** AVENUE/16TH **AVENUE** BIKEWAY (MACARTHUR **BOULEVARD** TO EMBARCADERO), **NINETY** THOUSAND DOLLARS (\$90,000.00); (2) BICYCLE DETECTION AT ACTUATED TRAFFIC SIGNALS, ONE HUNDRED THOUSAND DOLLARS **CASTLEMONT** (\$100,000.00); **STAIRS** REHABILITATION (3)(MAĆARTHÚR BÓULEVARD TO THERMAL STREET), ONE HUNDRED THOUSAND DOLLARS (\$100,000.00); (4) CITYRACKŚ VIII BICYCLE PARKING PROJECT, SEVENTY-FIVE THOUSAND DOLLARS (\$75,000.00); AND (5) SCHOOL SAFETY IMPROVEMENTS AT VARIOUS LOCATIONS, FIFTY THOUSAND DOLLARS (\$50,000.00)

WHEREAS, Article 3 of the Transportation Development Act (TDA), Public Utilities Code Section 99200 et seq. authorizes the submission of applications to a regional transportation planning agency for the funding of projects exclusively for the benefit and/or use of pedestrians and bicyclists; and

WHEREAS, the Metropolitan Transportation Commission (MTC), as the regional transportation planning agency for the San Francisco Bay region, has adopted MTC Resolution No. 875, revised, entitled "Transportation Development Act, Article 3, Pedestrian/Bicycle Projects," which delineates procedures and criteria for submission of requests for the allocation of "TDA Article 3" funding; and

WHEREAS, the MTC requires that resolutions authorizing the application, acceptance and appropriation of funds include an "Exhibit A: Findings", verifying that there are no legal, fiscal, or other impediments to the implementation of this project; and

WHEREAS, staff has determined that there are no legal impediments or other factors that would affect the City's ability to deliver the projects, that there is sufficient availability of City staff resources and adequate funding to complete the projects, that environmental and right-of-way issues have been reviewed and that fund obligation deadlines will not be jeopardized; and

WHEREAS, these determinations verify that the five projects meet MTC's criteria for eligibility; and

WHEREAS, MTC Resolution No. 875, revised, requires that requests for the allocation of TDA Article 3 funding be submitted as part of a single, countywide coordinated claim from each county in

the San Francisco Bay region and that the Alameda County Public Works Department coordinates this claim for Alameda County; and

WHEREAS, the City of Oakland declares it is eligible to request an allocation of TDA Article 3 funds pursuant to Section 99234 of the Public Utilities Code; and

WHEREAS, the City of Oakland desires to apply for \$415,000.00 in FY 2010-11 TDA Article 3 Funds for five (5) projects, as follows: (1) Ardley Avenue/16<sup>th</sup> Avenue Bikeway (MacArthur Boulevard to Embarcadero), Ninety Thousand Dollars (\$90,000.00); (2) Bicycle Detection at Actuated Traffic Signals, One Hundred Thousand Dollars (\$100,000.00); (3) Castlemont Stairs Rehabilitation (MacArthur Boulevard to Thermal Street), One Hundred Thousand Dollars (\$100,000.00); (4) CityRacks VIII Bicycle Parking Project, Seventy-Five Thousand Dollars (\$75,000.00); and (5) School Safety Improvements at Various Locations, Fifty Thousand Dollars (\$50,000.00); and

WHEREAS, the project areas are described in more detail in the City Administrator's agenda report accompanying this resolution; and

WHEREAS, the requirements of the California Environmental Quality Act (CEQA) have been satisfied; now, therefore, be it

**RESOLVED:** That based on the determinations contained in the City Administrator's report accompanying this resolution the City Council of the City of Oakland finds as follows:

- 1. The City of Oakland is eligible to request an allocation of TDA Article 3 Funds pursuant to Section 99234 of the Public Utilities Code; and
- There is no known pending or threatened litigation that might adversely affect any of the five (5) projects described in the City Administrator's agenda report accompanying this item, as follows: (1) Ardley Avenue/16<sup>th</sup> Avenue Bikeway (MacArthur Boulevard to Embarcadero); (2) Bicycle Detection at Actuated Traffic Signals; (3) Castlemont Stairs Rehabilitation (MacArthur Boulevard to Thermal Street); (4) CityRacks VIII Bicycle Parking Project; and (5) School Safety Improvements at Various Locations, or that might impair the ability of the City of Oakland to carry out these projects; and be it

FURTHER RESOLVED: That the projects are exempt from CEQA pursuant to CEQA Guidelines Sections 15061(b)(3), 15301(c), 15301(f), and/or 15304(h); and on a separate and independent basis, the City is relying on the previously certified and adopted Environmental Impact Report for the Bicycle Master Plan (2007) for the following projects: Ardley Avenue/16th Avenue Bikeway (MacArthur Boulevard to Embarcadero), Bicycle Detection at Actuated Traffic Signals, and CityRacks VIII Bicycle Parking Project; and be it

FURTHER RESOLVED: That the City Council hereby authorizes the application, acceptance, and appropriation of FY 2010-11 TDA Article 3 funds in the amount not to exceed \$415,000.00 to be deposited and appropriated as follows: (1) \$90,000.00 for the Ardley Avenue/16th Avenue Bikeway (MacArthur Boulevard to Embarcadero) into Transportation Development Act (TDA) Article 3 Fund (2162), Traffic Engineering Organization (92246), Street Construction Account (57411), and a new project number to be established; (2) \$100,000.00 for the Bicycle Detection at Actuated Traffic Signals into the Transportation Development Act (TDA) Article 3 Fund (2162), Capital Projects-Electrical Projects Organization (92228), Electrical and Plumbing Supplies Account (52511), and a new project number to be established; (3) \$100,000.00 for Castlemont Stairs Rehabilitation (MacArthur Boulevard to Thermal Street) into the Transportation Development Act (TDA) Article 3 Fund (2162), Capital Projects-Streets and Structures Organization (92242), Street Construction Account (57411), and a new project number to be established; (4) \$75,000.00 for CityRacks VIII Bicycle Parking Project into the Transportation Development Act (TDA) Article 3 Fund (2162), Traffic Engineering Organization (92246), Supplies and Equipment Account (52920), and a new project number to be established; and (5) \$50,000.00 for School Safety Improvements at Various Locations into the Transportation Development Act (TDA) Article 3 Fund (2162), Traffic Engineering Organization (92246), Street Construction Account (57411), and a new project number to be established; and be it
