**RESOLUTION INITIATING THE FY 2003-04 ASSESSMENT PROCESS FOR THE CITY OF OAKLAND LANDSCAPING AND LIGHTING ASSESSMENT DISTRICT AND AUTHORIZING THE CITY MANAGER TO ORDER A PRELIMINARY ENGINEER'S REPORT PURSUANT TO THE CALIFORNIA STREETS AND HIGHWAYS CODE SECTION 22622**

**WHEREAS**, the City of Oakland Landscaping and Lighting Assessment District (LLAD) was established on June 23, 1989 under the authority of the California Streets and Highways Code Section 22500, et seq., known as the Landscaping and Lighting Act of 1972; and

**WHEREAS**, the City desires to initiate the FY 2003-04 LLAD assessment for properties within the district boundaries; and

**WHEREAS**, the California Streets and Highways Code Section 22622 requires that the City adopt a resolution describing any proposed new improvements or any substantial changes in existing improvements and order the District Engineer to prepare and file a report with the City Clerk for further submission to the City Council; now, therefore be it

**RESOLVED:** That the existing boundaries and improvements of the LLAD remain the same as those described in the FY 2002-03 Final Engineer's Report approved by the City Council on May 28, 2002; and be it

**FURTHER RESOLVED:** That the City Council initiates the annual assessment process for the City of Oakland Landscaping and Lighting Assessment District for FY 2003-04, and be it

**FURTHER RESOLVED:** That the City Council authorizes the City Manager or his designee to order a FY 2003-04 Preliminary Engineer's Report for the City of Oakland Landscaping and Lighting Assessment District, and be it

**FURTHER RESOLVED:** That the Preliminary Engineer's Report shall be filed with the City Clerk for submission to the City Council for further action.
