Interests & Experiences

Please tell us how your qualifications and participation will relate to the requested board and/or commission's mission.

I am a resident of Oakland, California and I have over 22 years of experience in social services including serving as director for numerous family and SRO homeless shelters. Additionally, I have also led supportive housing programs and have been the deputy director of a domestic violence organization. As an experienced Licensed Clinical Social Worker and the current Associate Director of Supportive Housing for Eden Housing Inc. I am responsible for developing and implementing permanent supportive housing throughout California for those who have special needs and experiencing homeless. Combating homeless and finding solutions to help those who are unhoused is a passion and commitment of mine. I have been invited to share my experience and expertise to the those who work to provide affordable and supportive housing. For example, I have been a presenter at the Affordable Housing Management Association of Northern California in Hawaii (AHMA). I will also be presenting this spring at the Corporation of Supportive Housing (CSH) Summit in Philadelphia. PA where I will discuss best practices on providing permanent supportive housing for Transitioned Aged Youth (TAY). I have carried out a wide range of activities including marketing programs, creating, and maintaining partnerships, supervising staff, budget administration, program supervision, managing projects, and fundraising/development. For example, I lead the development of a legislative ad hoc committee for Laurel House's, a domestic violence organization in Pennsylvania, board of directors to improve our relationships with federal, state, and county elected officials. As a result, I was able to negotiate a significant funding allocation to enhance programming at the organization. The organization was left in a position to finalize a \$152,000 allocation from state legislators, pending approval by the state house. While working for The Salvation Army of Southeastern Pennsylvania and Delaware, I oversaw a \$1.2 million budget for two housing facilities, as well as developed a strategic plan involving a physical move of our program to a new location. Additionally, I obtained funding to increase our permanent supportive housing program's capacity from 12 families to 26 families. As director of the Lessig-Booth Family Residence, an emergency shelter, I combated dire financial constraints, and a possible facility closing, due to decreasing grant monies in response to a low level of occupancy in the facility. As a result of my leadership, grant funding increased by \$162,000; community members contributed significantly to our finances; and residential occupancy increased. The improvements contributed to expanding the occupancy rate by 33%; the number of residents obtaining independent housing also doubled. It is my hope that you will find my experience and knowledge regarding housing will be beneficial to the Oakland Homeless Commission and that my experience as a social worker and administrator working with those who are unhoused will enhance the work that the commission is already performing.



WHEREAS, members serving initial appointments shall serve staggered terms of one (1), two (2) or three (3) years, all appointments for subsequent terms shall be for three-year terms; and all member terms shall begin on the date of the first six (6) appointments and future terms shall begin and end on that date; and

WHEREAS, the Honorable Mayor Kevin Jenkins has reappointed Marcus Christmas, Marlene Hurd, and Mark Walker, to the Commission on Homelessness, to the terms listed below; now, therefore, be it **RESOLVED**, that the City Council hereby confirms the Mayor's reappointments of the following individuals to the Commission on Homelessness as set forth below:
