**RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO EXECUTE A GRANT AGREEMENT WITH THE OAKLAND PARKS AND RECREATION FOUNDATION, AS FISCAL SPONSOR FOR THE EAST OAKLAND NEIGHBORHOOD INITIATIVE, IN AN AMOUNT NOT TO EXCEED TWENTY-FIVE THOUSAND DOLLARS (\$25,000), TO DISBURSE RESILIENCE HUB GRANT FUNDS PREVIOUSLY AWARDED TO THE CITY OF OAKLAND BY PACIFIC GAS AND ELECTRIC COMPANY**

**WHEREAS**, the City of Oakland previously received a twenty-five thousand dollar (\$25,000) Resilience Hub Grant from Pacific Gas and Electric Company (PG&E) on September 29, 2023 to support community resilience planning efforts in East Oakland; and

**WHEREAS**, the City has accepted and appropriated the grant funds on October 31, 2023, which are available in Fund 2999, Organization 02161, Project 1007317 – PGE SUSTAINABILITY GRANT for expenditure consistent with the grant's purposes; and

**WHEREAS**, the East Oakland Neighborhood Initiative (EONI) is a community led collaborative focused on equity-based planning and community-led development to identify and advance resident priorities in Deep East Oakland, including climate resilience; and

**WHEREAS**, EONI convened the East Oakland Resilience Design Summit to engage residents, community-based organizations, and local stakeholders in identifying trusted community serving sites for potential Resilience Hubs and defining community prioritized features, services, and programming; and

**WHEREAS**, the City's 2030 Equitable Climate Action Plan (ECAP) establishes the development of community serving resilience hubs as a priority action area (Action A-1), and EONI's completed engagement provides community informed guidance toward this goal; and

**WHEREAS**, the City of Oakland will use community input generated through the Design Summit to inform the identification, development, and programming of future municipal Resilience Hubs in East Oakland; and

**WHEREAS**, the Oakland Parks and Recreation Foundation (OPRF), as fiscal sponsor for EONI, is prepared to administer grant funds in support of these community driven resilience planning activities; and

**WHEREAS**, disbursing the grant funds to OPRF, as fiscal sponsor for EONI, will support continued planning, coordination, and development of community informed Resilience Hub strategies in East Oakland; now, therefore, be it

**RESOLVED:** That the City Administrator is hereby authorized to execute a grant agreement with the Oakland Parks and Recreation Foundation, as fiscal sponsor for the East Oakland Neighborhood Initiative, in an amount not to exceed twenty-five thousand dollars (\$25,000), to support community resilience hub planning, engagement, site identification, and design activities in East Oakland, using funds previously awarded to the City of Oakland by PG&E; and be it

**FURTHER RESOLVED:** That the City Administrator is authorized to negotiate and enter into a grant agreement with the Oakland Parks and Recreation Foundation, for a term beginning upon execution and ending no later than July 31, 2026, in an amount not to exceed twenty-five thousand dollars (\$25,000), and to conduct all negotiations, execute all documents, and take any other actions necessary and consistent with this Resolution to implement the grant agreement.
