

**RESOLUTION RE-APPOINTING JAMES MATTHEWS  
AS THE DISTRICT TWO YOUTH MEMBER  
OF THE CHILDREN'S FUND PLANNING AND OVERSIGHT COMMITTEE**

**WHEREAS**, City of Oakland Charter Section 1300 creates the Children's Fund Planning and Oversight Committee to oversee the KIDS FIRST! Oakland Children's Fund, which was established to help young people in Oakland grow to become healthy, productive and honorable adults; and

**WHEREAS**, Charter Section 1300 specifies that members of the Children's Fund Planning and Oversight Committee are to be appointed, two members by each Member of the City Council and three members by the Mayor, to serve one-year terms; and

**WHEREAS**, James Matthews is currently serving a one-year term as the District 2 Youth Representative on the Children's Fund Planning and Oversight Committee beginning August 1, 2008 and ending July 31, 2009; and

**WHEREAS**, Councilmember Patricia Kernighan has appointed James Matthews to an additional one-year term on the Children's Fund Planning and Oversight Committee beginning August 1, 2009 and ending July 31, 2010; now therefore, be it

**RESOLVED**, that by the appointment of Councilmember Kernighan the following individual is hereby confirmed:

James Matthews, District 2 Youth Representative, to the term beginning August 1, 2009 and ending July 31, 2010, for a period of one year as set forth in the Charter of the City of Oakland.
