INTRODUCED BY COUNCILMEMBER [IF APPLICABLE]

**Resolution Appropriating Fund Balance From Fund 2211: Measure B Local Streets And Roads In An Amount Not To Exceed Seventy-Five Thousand Dollars (\$75,000) For The Purchase Of Equipment To Sweep Bicycle Lanes In Accordance With The City's Purchasing Programs And Policies**

**WHEREAS**, This resolution would enable Oakland Public Works (OPW) to purchase narrow-profile street sweeping equipment; and

**WHEREAS**, This equipment would be used primarily to ensure curbside bikeways are swept clear, eliminating debris that could pose hazards for people riding bicycles or scooters and reducing impacts to Oakland's storm drain system and watershed; and

**WHEREAS**, The narrow-profile sweeper would also be used to sweep other street elements that a traditional street sweeper could not navigate, such as painted pedestrian refuges and City parking garages; and

**WHEREAS**, Traditional larger sweepers are unable to enter narrow curbside bikeways, many City parking garages, and painted pedestrian refuges; and

**WHEREAS**, Sweeping streets is a critical function for the City in order to reduce the flow of both organic debris and inorganic trash into the storm drain system; and

**WHEREAS**, the estimated cost for this streetsweeper is One Hundred and Fifty Thousand Dollars (\$150,000); and

**WHEREAS**, Seventy-Five Thousand Dollars (\$75,000) is available from the Equipment Fund 1720 (Project 100010 Organization 30672, Account 57611 Program NB35).; and

**WHEREAS**, an additional Seventy-Five Thousand Dollars \$75,000 is needed to make the purchase; and

**WHEREAS**, the City Council finds that the City lacks this equipment to perform the necessary street sweeping and that the purchase of this equipment is in the public interest to ensure the usability of all bike lanes and the performance of the City's storm drain system; and

**WHEREAS**, the City Administrator will procure bicycle lane sweeping equipment in accord with the City's Purchasing Ordinance and contracting program requirements including, without limitation, advertising and competitive bidding and award to the lowest responsible, responsive bidder; now, therefore, be it

**RESOLVED:** That City Council Appropriates the Fund Balance From Fund 2211: Measure B Local Streets And Roads In An Amount Not To Exceed Seventy-Five Thousand Dollars (\$75,000) For The Purchase Of Equipment To Sweep Bicycle Lanes In Accordance With The City's Purchasing Programs And Policies.


