RESOLUTION AUTHORIZING AWARD OF A CONSTRUCTION CONTRACT TO ANDES CONSTRUCTION, INC. FOR THE REHABILITATION OF SANITARY SEWERS AND STORM CULVERT IN THE EASEMENT OFF BUTTERS DRIVE (PROJECT NO. C135410) FOR THE AMOUNT OF TWO HUNDRED EIGHTY-FIVE THOUSAND ONE HUNDRED SIXTY-SEVEN DOLLARS (\$285,167.00)

WHEREAS, on April 9, 2007, three bids were received by the Office of the City Clerk of the City of Oakland for the Rehabilitation of Sanitary Sewers and Storm Culvert in the easement off Butters Drive (Project No. C135410); and

WHEREAS, Andes Construction, Inc. a certified SLBE bidding as a prime, is the lowest responsive and responsible bidder for the project; and

WHEREAS, there are sufficient funds in the project budget for the work. Funding for this project is available in the Sewer Service Fund (3100), Capital Project Sanitary Sewer Design Organization (92244), and Sewers Account (57417), Rehabilitation of Sanitary Sewers and Storm Culvert in the easement off Butters Drive (Project No. C135410) and these funds were specifically allocated for this project; and

WHEREAS, the City lacks the equipment and qualified personnel to perform the necessary work; and

RESOLVED: That the contract for the Rehabilitation of Sanitary Sewers and Storm Culvert in the easement off Butters Drive (Project No. C135410) is hereby awarded to Andes Construction, Inc. in accordance with the terms of its bid therefore, dated April 9, 2007, for the amount of Two Hundred Eight-Five Thousand One Hundred Sixty-Seven Dollars (\$285,167.00) and City plans and specifications for the project; and be it

FURTHER RESOLVED: That the plans and specifications prepared by the Director of Public Works for this project are hereby approved; and be it

FURTHER RESOLVED: That the amount of the bond for faithful performance, \$285,167.00, and the amount for a bond to guarantee payment of all claims for labor and materials furnished and for the amount due under the Unemployment Insurance Act, \$285,167.00, with respect to such work are hereby approved; and be it

FURTHER RESOLVED: That the City Administrator is hereby authorized to enter into a contract with Andes Construction, Inc. on behalf of the City of Oakland and to execute any amendments or modifications to said agreement within the limitations of the project specifications; and be it

FURTHER RESOLVED: That the contract shall be reviewed and approved by the City Attorney and placed on file in the Office of the City Clerk; and be it
