Re: SUPPLEMENTAL INFORMATION REGARDING RESOLUTION AUTHORIZING AWARD OF A CONSTRUCTION CONTRACT TO AJW CONSTRUCTION FOR ON-CALL SIDEWALK REPAIR AT VARIOUS LOCATIONS THROUGHOUT THE CITY OF OAKLAND FOR FISCAL YEAR 2003-2004 IN THE AMOUNT OF \$346,000.50 (PROJECT NO. C78060)

On February 10, 2004, the Public Works Agency presented a report to the Public Works Committee on the On-Call Sidewalk Repair Project. The Committee directed staff to provide supplemental information regarding the current priority (hotspot) sidewalk repair list.

The current sidewalk repair priority list is shown in *Attachment A* per the Public Works Committee request. It is anticipated that approximately 50 out of the 107 locations can be repaired on the On-Call Sidewalk Repair Project (C78060). The estimated amount of sidewalk area that can be repaired under this contract is 29,439 square feet for the \$346,000.50 contract. Since the On-Call contract will be used to repair the most severely damaged locations, the repair locations on this contract may change as higher severity locations are identified or emergency repair work is needed over the course of the contract.
