RESOLUTION ORDERING THE MAKING OF AMENDED REASSESSMENTS PURSUANT TO PART 10 OF DIVISION 10 OF THE STREETS AND HIGHWAYS CODE AND DIRECTING ACTIONS WITH RESPECT THERETO SKYLINE SEWER ASSESSMENT DISTRICT

RESOLVED by the City Council (the "Council") of the City of Oakland, County of Alameda, State of California, that:

WHEREAS, pursuant to the Improvement Bond Act of 1915 and Resolution No. 71096 C.M.S., titled A Resolution Authorizing Issuance of Bonds, adopted by this Council on June 14, 1994, special assessments were confirmed to pay the costs of the acquisitions and improvements as more particularly described in said Resolution. Said Assessments are set forth on An Assessment Diagram and Assessment Roll, heretofore confirmed by this Council and filed and recorded with the City Clerk of the City of Oakland and the County of Alameda; and

WHEREAS, certain parcels of land designated as Assessment Numbers 1G and 1H upon which there are unpaid Assessments where bonds have been issued under the Improvement Bond Act of 1915, commencing with Section 8500 of the Street and Highways Code of California, have been reconfigured so that they no longer conform to the original parcel boundaries as shown on said Assessment Diagram;

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED as follows:

The Superintendent of Streets of the City of Oakland shall cause to be filed with the City Clerk the Assessment Apportionment Reports, an Amended Assessment Diagram and Amended Assessment Roll of Assessment Numbers 1G and 1H, which were previously recorded on the 24th day of June 1994 in Book 9, Page 35, Document No. 94234810, segregating and apportioning the unpaid installments of the original Assessments in accordance with the benefits to the several parts of the original parcel.
