RESOLUTION APPROVING 1) THE CONVERSION OF A "NO PARKING" ZONE TO A "NO PARKING/TOW AWAY" ZONE ALONG THE PERIMETER OF OAK GLEN PARK ON RICHMOND BOULEVARD; AND 2) THE INSTALLATION OF STOP SIGNS ALONG NORFOLK DRIVE, BRISTOL DRIVE, SHERWICK DRIVE, BUCKINGHAM BOULEVARD, GRAVATT DRIVE, GRAND VIEW DRIVE, WEST VIEW DRIVE, AND VICENTE PLACE AT EIGHT "T" INTERSECTIONS

WHEREAS, O.M.C. Section 10.28.080 enables the Transportation Services Division (TSD) to prohibit parking on one side of a street to advocate traffic safety and emergencyvehicle access if the street is less than 30 feet wide; and

WHEREAS, TSD has installed "No Parking Anytime" signs along the perimeter of Oak Glen Park on Richmond Boulevard, which is less than 30 feet wide; and

WHEREAS, there has been a blatant disregard for the existing "No Parking" signs, especially at night when enforcement is lax; and

WHEREAS, the vehicles illegally parked along Oak Glen Park have caused difficulties for vehicles to pass through and pose a serious hazard for emergency-vehicle access; and

WHEREAS, California Vehicle Code (CVC) Section 22651(n) allows local authorities. by resolution or ordinance, to establish and enforce a "No Parking/Tow Away" zone if proper signs giving notice thereof are in place; and

WHEREAS, by changing the enforcement policy from citation to tow away, violating vehicles may be removed immediately, and the no parking policy will be regarded more seriously; and

WHEREAS, an investigation conducted in response to a request from the North Hill Phoenix Association indicates that the installation of stop sign(s) at eight "T" intersections along Norfolk Drive, Bristol Drive, Sherwick Drive, Buckingham Boulevard, Gravatt Drive, Grand View Drive, West View Drive, and Vicente Place will enhance traffic and pedestrian safety; now, therefore, be it

RESOLVED: That the conversion of the existing "No Parking" zone along the perimeter of Oak Glen Park on Richmond Boulevard to a "No Parking/Tow Away" zone is hereby approved; and, be it

FURTHER RESOLVED: That the installation of stop sign(s) at the following eight "T" intersections is hereby approved:

LOCATIONS OF STOP SIGN(S) INSTALLATION

- 1. Buckingham Boulevard and Norfolk Drive—install stop sign stopping Norfolk Drive.
- 2. Sherwick Drive and Bristol Drive—install stop signs stopping Bristol Drive.
- 3. Charing Cross Road and Sherwick Drive—install stop sign stopping Sherwick Drive.
- 4. Bristol Drive and Buckingham Boulevard—installing stop signs stopping Buckingham Boulevard.
- 5. Amito Avenue and Gravatt Drive—install stop sign stopping Gravatt Drive.
- 6. Gravatt Drive and Grand View Drive—install stop sign stopping Grand View Drive.
- 7. Grand View Drive and West View Drive—install stop sign stopping West View Drive.
- 8. Vicente Road and Vicente Place—install stop sign stopping Vicente Place
