Dear President De La Fuente and Members of the City Council:

Pursuant to Section 401 of the Charter, the City Attorney has prepared and recommends settlement of the above-entitled matter arising from alleged civil rights violations during the arrest of the plaintiff for a total sum of Fifteen Thousand Dollars and No Cents (\$15,000.00), to be made payable to Alphonso Baker and John Burris, Esq., his attorney.

The case alleges excessive force in the course of an arrest for brandishing a knife, which occurred on November 29, 2000. Mr. Baker claims that he was kicked in the head twice. The plaintiff's position appears to be supported by the photographs of his injuries. Mr. Baker suffered an injury to his eye that required fourteen stitches.

The settlement is recommended to avoid the risk of an adverse verdict at trial and the additional exposure for attorney's fees should that occur.
