ORDINANCE AMENDING OAKLAND MUNICIPAL CODE SECTION 10.48.010 "SCHEDULE OF PARKING FINES" TO INCREASE THE CITY OF OAKLAND FINE FOR A VIOLATION OF OAKLAND MUNICIPAL CODE SECTION 10.36.30B VALID PARKING RECEIPT NOT DISPLAYED" FROM \$35.00 (THIRTY FIVE DOLLARS) TO \$55.00 (FIFTY FIVE DOLLARS)

WHEREAS, the City of Oakland collects fines for violations of the Oakland Traffic Code as set forth in Title 10 of the Oakland Municipal Code; and

WHEREAS, the City of Oakland has a duty to enforce parking violations as set forth in the Oakland Municipal Code; and

WHEREAS, the City of Oakland increased some of the parking violation fines set in Oakland Municipal Code Section 10.48.010 "Schedule of Parking Fines" effective July 1, 2009; and

WHEREAS, a Public Hearing was held on March 16, 2010 to review the proposed change herein; now, therefore

THE COUNCIL OF THE CITY OF OAKLAND DOES ORDAIN AS FOLLOWS:

Section 1. Oakland Municipal Code (O.M.C.) Section 10.48.010 "Schedule of Parking Fines" is hereby amended as set forth below. Additions are indicated by <u>underscoring</u> and deletions are indicated by <u>strike through type</u>; portions of ordinances not cited or not shown in underscoring or strike-through type are not changed.

Section 2. Severability. If any article, section, subsection, sentence, clause, or phrase of this ordinance or exhibit is held to be invalid or unconstitutional, the offending portion shall be severed and shall not affect the validity of remaining portions which shall remain in full force and effect.

Section 3. Effective Date. This ordinance shall become effective as provided in Section 216 of the Charter of the City of Oakland.
