

RESOLUTION NO. _____ C.M.S.

RESOLUTION AUTHORIZING THE CITY MANAGER ON BEHALF OF THE CITY OF OAKLAND TO ACCEPT AND APPROPRIATE A GRANT IN AN AMOUNT NOT TO EXCEED FORTY-NINE THOUSAND SIX HUNDRED AND FORTY-SIX DOLLARS (\$49,646) FROM THE STATE OF CALIFORNIA, OFFICE OF TRAFFIC SAFETY FOR A FOUR-MONTH CALIFORNIA SEAT BELT COMPLIANCE CAMPAIGN WITHIN THE POLICE DEPARTMENT

WHEREAS, it is anticipated that grant funds totaling up to forty-nine thousand six hundred and forty-six dollars (\$49,646) will be received from the State of California, Office of Traffic Safety for the Police Department's participation in the California Seat Belt Compliance Campaign program; and

WHEREAS, the California Seat Belt Compliance Campaign is geared toward focusing public information and enforcement on persons who fail to use seat belts during the November 2003 Buckle Up America/Operation ABC National Mobilization period; and

WHEREAS, the California Seat Belt Compliance Campaign is a collaborative effort between the California Highway Patrol, the Office of Traffic Safety and local law enforcement agencies; and

WHEREAS, the proposed grant will not cover any indirect costs related to the performance of overtime service; now, therefore be it

RESOLVED: That the City Council hereby authorizes the City Manager or her designee to accept and appropriate a grant in an amount not to exceed \$49,646 from the State of California, Office of Traffic Safety to the State of California Grant Fund: 2999, Org.: 104811, in a Project Account to be determined; and be it

FURTHER RESOLVED: That the City Central Services Overhead costs of \$8,822 (17.77%) are hereby waived; and be it

FURTHER RESOLVED: That the City Council hereby authorizes the City Manager as agent of the City to conduct all negotiations and related actions and to sign all applications and agreements that may be necessary for the completion of the aforementioned grant.
