Pursuant to §401 of the Charter, and the action of the Council at its September 30, 2003, closed session, the City Attorney has prepared and requests your approval of a resolution authorizing compromise and settlement of the above-entitled action in the sum of Fifteen Thousand Dollars (\$15,000.00), payable to Kereem Thurston and his attorney of record, John L.Burris, Esq.

This action arises out of an arrest on October 15, 2002. Mr. Thurston claims that the officers used excessive force against him. The officers deny Mr. Davidson's allegations. This settlement is recommended as a compromise of this matter and to avoid a potentially adverse jury verdict should the matter be tried.
